And I leave to my Executors herein named, for the uses herein stated, all the property, real & personal of which I may die possessed - requesting them also to attend to such other duties as are here enjoined. 1. I request that my body be interred in the grave yard of the English Lutheran Church near the remains of my parents - that my Coffin may be of plain mahogany enclosed in a wooden box & that a Stone be erected over my grave at also that of my Husband at Abbeville - the cost not exceeding fifty Dollars each. 2. I request that my Executors be funeral expenses & all my lawful debts be paid. 3. As I am indebted to my Brother in law Wm See Esq. for six years board which I think amounts to Twelve hundred Dollars (\$1200) I request this debt to be paid from Shares I own in the planters & Mechanics Bank. 4. I give to my Nephew W. Wm See all the shares I own in the State Bank of this City. 5. I give & bequeath to my beloved Sister in law Mrs Louisa C Markley all the shares I own in the Bank of Charleston. 6. I bequeath to my Nephews, John, Frank, Ben, Mary & Keriah One hundred Dollars each to be paid them out of the proceeds of a Note I hold against the Estate of Patrick Noble of \$1500 or upwards - from the same amount also I leave to the Ladies Benevolent Society Four Hundred Dollars. 7. Should there be any balance after all my debts & Legacies have been paid I request that it may be equally divided between Mrs Louisa C Markley & my Nephew W. Wm See. 8. I request my Executors to erect over the grave of my Brother Benj A Markley a Tomb Stone of the cost of my own. 9. In as much as I do not wish the Sum or Sums herein left to Mrs Louisa C Markley to be liable for any of her debts I leave the Rev J Bachman as her Trustee to pay to her the annual Interest of this amount or such portions of the principal as he may see fit - and whatever of this Legacy to her may be left at the time of her death I request may be equally divided between the Ladies

paid I request that it may be equally divided between Mrs. Louisa C. Markley & my Nephew
L. W. Lee. 8. I request my Executors to erect over the grave of my Brother Benj. A.
Markley a Tomb Stone of the cost of my own. 9. In as much as I do not wish the Sum
or sums herein left to Mrs. Louisa C. Markley to be liable for any of her debts I leave the
Rev. J. Bachman as her Trustee to pay to her the annual Interest of this amount or
such portions of the principal as he may see fit - and whatever of this Legacy to her
may be left at the time of her death I request may be equally divided between the Ladies
Benevolent & the Ladies Fuel Societies. 10. I hereby constitute & appoint the Rev. L. John
Bachman & Benjamin M. Lee as my Executors. Given under my hand & seal at
Charleston South Carolina this 5th day of Oct. 1844. In the 68th year of American
Independence.

all my aforesaid Estate, real and personal wheresoever, and whatsoever, unto Edward
Memore, his heirs, Executors, Administrators and assigns forever. Lastly I nominate
constitute and appoint the said Charles J. Lowndes, Executor of this my last will &
testament. but if the said Charles J. Lowndes, should die in my life time, then I
