and that my debts if any be paid out of the Rent and after that, that the Rents

be equally divided amongst my said Grand Children, and the Survivors
and Successors of them until the Youngest attain the Age of Twenty-one Years
at Which time it is my Will that One or more may sell and convey the same
Interest of the Others so that the same and Lot be put into the hands of
and if they refuse to do this then it is my Will that the same be retained
for the benefit of all my said Grand Children during their joint lives, and
from and after their respective Deaths for the benefit of the Survivors & Successors
- so that the last Surviving Grand Child may take and hold the same
in Fee Simple - Item, I give and bequeath unto my Grand Daughter Maria
McTimony, Wife of Joseph Cupress a Silver Dish, a double full
of Drawers, a Stab and all the furniture of her late Aunt Oliver P. Rightton
to Which she lays Claim - Item, I give and bequeath unto my Grand Son
John McCully Rightton Wood my Toy Joseph, a Silver Tankard, a Bed
and Bedstead - Item, I give and bequeath unto my Grand Daughter Mary
Poulton Wood and Elizabeth Rightton Wood each One Set of Drawers, One
Bed & Mattress, a half Doz Tea Spoons & Milk Pot - I also give and bequeath
unto William G. Wood & Peter Wood my Negro Woman Charlotte & her future
issue and increase in trust for my Grand Daughter Mary Poulton Wood and
not to be Subject to the debts Contracts or Contract of her Husband should
she Marry - Item, I give and bequeath unto William G. Wood & Peter Wood
my little Boy Edward Jones in trust for my Grand Daughter Elizabeth Rightton
Wood for and during the term of her Natural life and not to be Subject to the
debts, Contracts or Contract of her Husband should she Marry, and after
the Death of my said Grand Daughter Elizabeth Rightton Wood then I direct
my Executors hereinafter Named to Emancipate the said Edward Jones if the
