Negroes Anthony, Sabena, Sarah, Rose, Johnny, Abram, ^{Nathaniel} ~~Matthew~~,
Nancy and her Children Jimmy, Jacob, Jener, Bella. ~~Thos Lee~~ ^{Ed}
Witness. Saml Wragg, Harris Simons, O H Dawson. Proved
before Thos Lee Esq. Q.C. J.D. on the 31st day of October 1839 and
at the same time qualified W^m Kezia Lee Executor.

16 State of South Carolina, Charleston District. In
the Name of God Amen. I Sarah Hutchinson of the
State and District aforesaid Widow being in good health of
body and of sound and disposing mind do make publish
and declare this to be my last Will hereby revoking all other
Wills heretofore made by me; And first I commit my soul
to God who gave it and my Body to the earth and as to such
worldly Estate wherewith it hath pleased God to intrust me
I dispose of the same as follows. In witness I write that
all my just debts and funeral expences, and all charges
touching the proving^{of} or otherwise concerning this my Will shall
in the first place out of my Estate be paid, and after payment
thereof then the rest and residue of my Estate of every kind whatsoever
I give to my affectionate Niece Mary B Wilson and my affectionate
Nephew Morton A Waring their heirs and assigns forever to be
equally divided between them in the following manner that

to say all my Negroes shall be valued by three Individuals to be named and
appointed by my said Niece Mary B Wilson and my said Nephew
Morton A Waring and after they shall have been so valued, then my
said Nephew Morton A Waring shall secure to be paid to my said
Niece Mary B Wilson one half of the Amount of said valuation to
her and her heirs forever. Then the whole of the said Negroes to
remain the property of the said Morton A Waring his heirs and
assigns forever. It is my intention by the foregoing disposition of my
property to give all my Negroes to my Nephew Morton A Waring provided
he secures to be paid to my Niece Mary B Wilson one half of their value
the residue of my Estate to be equally divided between them share and
share alike. I do hereby appoint Morton A Waring my Executor of
this my Will. Signed sealed and dated at Charleston this Third
day of January in the Year Eighteen Hundred and thirty three
