Joseph Blake Esquires the Executors in the said will named have Refused to
Take upon them the burthen of the Execution of the said Last will and
Testament and Desiring that the said goods Rights and Credits which
Were of the said Thomas Boone Deceased may be well and Truly
Administred concerted and Disposed of, I do therefore grant unto you
the said Ann Boone on behalf and as wife and attorney of the said

Full Power by the Tenour of these Presents to administer the goods Rights
and Credits of the said Deceased ^{whenever he was a free person} ~~with~~ his said Testament any manner
of way Concerning annexes, and to ask levy recover and Receive the
said goods rights and Credits and to pay the Debts in which the Deceased
Boone obliged so far forth as the said goods rights and Credits will
Extend According to their Rate and order of Law being first Sworn
on the Holy Evangelists Well and Truly to Administer the same
to make a full and Perfect Inventory and Appraisement and to Exhibit
the same unto the Secretarys Office in Charles Town on or before the

fourteenth Day of March Now next Ensuing & to Render
and just Account Calculation and Reckoning of your said
Administration when you shall be thereunto Required and
Advised by the Court and the said W^m. Amldoore, on
behalf and as wife and Attorney of Joseph Boone, your said
Husband's Administratrix of all and singular the goods, rights
and Credits of the said Thomas Boone Deceased with his will
by the 6 Presents
