all People to whom these presents shall come I William Martin of the Parish of St. John in the County of Southampton Esq. formerly Captain & Commander of his Majesties Ship the Dolphin late Capt. & Commander of his Majesties Ship the Anne do send Greeting Whereas Benjamin Dela Confidant of Charles Town in the Province of South Carolina in & by one obligation or Writing Obligatory under his hand & seal bearing date the Seventh day of August it was in the Year of our Lord one Thousand Seven hundred & Twenty four did become Bound unto me in the Penal sum of Twelve hundred Pounds of Lawfull money of England with condition thereunder written that if the P. Benjamin Dela Confidant his Heirs Ex. or Adm. should and did call & truly discharge to be Paid unto me my Ex. or Adm. or assigns the full sum of the hundred Pounds of Lawfull Money of Great Brittain at or upon the Seventh day of August it should be in the year of our Lord one Thousand Seven hundred without fraud or any fault Delay then the said obligation to be void & of none Effect or else to be & remain in full force as now by the said recited obligation relation being therein had may appear Now know ye that I the said William Martin have made & caused constitute appointed & in my Place & stead put & by these presents do make Ordain constitute & appoint in my Place & stead put Colonel Thomas Brown Esq. of South Carolina & George Anson Esq. Captain & Commander of his Majesties Ship the Swallow

Attorneys for me in my name & in the name of my assigns & assigns of and from the said Benjamin Dela Confidant his Heirs Ex. or Adm. or of his Ex. or Adm. any other Person or Persons whatsoever whom it shall think or may concern all & every the sum & sums of Money due or to grow due & Payable to me by force or virtue of the above recited obligation And In case of neglect or Default of Payment I do hereby authorize & empower the said Tho. Brown & George Anson or either of them to substitute one or more attorney or attorneys under them or either of them to complete commence & prosecute any action & of Actions suits or suits either in Law according to the Laws and Customs of South Carolina or according to the Laws & Customs of any other Province or State where the said Benjamin Dela Confidant his Heirs Executors or Administrators shall be Resident against the said Benjamin Dela his Heirs Ex. or Adm. for recovery thereof any Part thereof & thereupon to proceed Judgment or Decree & Cause the same to be Executed Imprisonment or otherwise against such Person or Persons whom it shall or may concern & also to attach distress Seize & condemn in due form of Law the Lands Tenements Goods Chattels and Effects of the said Benjamin Dela Confidant his Heirs Ex. or Adm. for or towards Satisfaction of the said Debt or Money due & Payable by virtue of the above recited obligation or any Part thereof and to appear before all Judges & Magistrate Courts or Courts whatsoever to answer defend and satisfy in all matters whatsoever Relating to the said Debt and upon Default of the said Money due & Payable to me or assigns or any Part thereof to give & deliver up possession

in the premises for the better & more speedily recovery
and getting in of the said sum & sums of money
due & to grow due by virtue of the said bills
obligations or any debt thereof as to my said attorney
or attorneys shall seem meet & I do hereby give &
grant unto my said attorney or either of them
power & authority one or more attorney or attorneys
to substitute what pleasure he or she or they shall see fit

be of worldly cares & concerns that he may the
better attend his Lord's Call at Death. Do make my
Last Will & Testament by these presents concerning
my soul to the mercies of God almighty in &
through Jesus Christ my Redeemer that my
body may be buried decently Consueteing & appointing
my loving friend John Daniel my executor to this
my Last Will & Testament to be the disposing of
my estate both Personal & Real.

My will is that my Funerall charges be paid next
that all my just debts be paid.
I give & bequeath unto my Uncle Henry Bellum & his
Heirs what ever Cash or lands or houses or what else
so ever may belong unto me my Decease, deducting
what I shall give unto my loving friend & kinsman John
Daniel as under mentioned

I give & bequeath unto my kinsman John Daniel
Sufficient money to buy him a suit of Mourning.

his Brand being a figure 2 and a fleur de lis in the
back thereof in the Margin and his mark being
a Swallow fork in the right Ear and a poplar leaf
in the left Ear
May 15th 1734
John Proctor of Newchill enters his Brand as in
the Margin and a frog and an under wheel in the
left ear and an upper heel and Swallow fork in the right
Ear for his brand mark.

May 15th 1734
John Proctor of Newchill enters his Brand as in
the Margin and a frog and an under wheel in the
left ear and an upper heel and Swallow fork in the right
Ear for his brand mark.
