ANN STANYARNE

17 R.^o In the Name of God Amen, I Ann Stanyarne of
N^o 2 Johns Island in the State of South Carolina
hereby revoking all former Wills at any time heretofore
by me made, do declare this to be my Last Will and Testa-
ment. First I hereby give and bequeath to my great
great niece Elizabeth Stanyarne Stevens and to the heirs
of her body Lawfully begotten or to be begotten forever
the following Slaves Sam Lydia Chloe Betty Befs Nancy and
Amey with the future issue and increase of the females
and for and in default of such Lawful issue of her my
said great great niece Elizabeth Stanyarne Stevens I do
hereby give and bequeath the aforesaid negro Slaves to
Doctor Joseph L Stevens for and during the term of his
natural Life and immediately after his decease I give
and bequeath the aforesaid Slaves with their issue and
increase to my great great Nephew John Mathews Flud his
Executors administrators and assigns forever. Also I
hereby give devise and bequeath to my said great great
Nephew John Mathews Flud, his executors administrators
and assigns forever all that my plantation called acorn-
hill Situated on Johns Island on which I now reside con-
taining Six hundred and fifty acres of Land, also I here-
by give and bequeath to my said great great Nephew John
Mathews Flud his executors administrators and assigns for-
ever the following negro Slaves Ned Dick Joe Cudjoe Lam-
bert Daphne Die Phillis Sue Carolina Priifs Edmond and San-
dy, field hands, and Joan Dennis Hannah and her children
John and Willis and Peter Philip and Binah my house ser-
vants with the future issue and increase of the females
also all the rest residue and remainder of my estate of
what nature or Kind soever which I have (after payment of
my just debts and funeral expences) I do hereby give and
bequeath to my said great great Nephew John Mathews Flud

his heirs Executors administrators and assigns forever:
 also it is my will and desire that my aforesaid estate
 be Kept entire and not divided until my said funeral ex-
 pences and just debts are paid which I require my Executor
 hereinafter named to do as speedily as possible. And Last-
 ly I do hereby nominate constitute and appoint my Said
 great great nephew John Mathews Flud Executor of this my
 Last Will and Testament. Witnefs my Hand and Seal this
 fourth day of January one thousand Eight hundred & twenty
 six. -----
