ant and future if one of the females, I also give him all the stock on the east Flantation to him his beirs and afeigns forever. 5th Item I give and bequeath to my Daughter Eartha the following Regro Slaves Vizt Will his Wife Dinah and their Chilgren, Isaac, Mary and her Children, Black Miley, Manny and her children Sancho his Wife Elsey and their Children Grace and her children, Jack Charlotte Frince his wife Rose and their Children with all the present and future ifsue of the females also give to my daughter Martha a Bond I now hold of Mr Paul grimbell's for One thousand Dollars to her her beirs and afsigns forever. 6th Item I give and bequenth to my daughter Bligabeth the following negro Slaves Vigt Peter and his Wife sally and their children, Dorah and her children Doll and her children Sandy Molly Hagar Bella Sue and Hagar with all IN the present & future if sue of the females, I also give to my daughter Elizabeth my Pew in St Pauls Church Charleston to her her heirs and afsigns forever. 7th Item I give to my Daughter Ann all my Stock Furniture Boats &c &c not heretofore given away and the rest and residue of my estate, which I may leave at my death to her and her heirs forever. 8th Ind Lastly I hereby nominate & appoint my son Richard and my two Nephews John and Richard LaRoche my Executors to this my Last Will and gestament hereby revoking & rendering Void any other will or testament but this, dated this minth day of September in the year of our Lord one thousand eight hundred & twenty Six and in the fifty first year of American Independence.
