I give and bequeath to my Daughter Maria Ravenel to her and her afsigns forever my negroes Dianna Mary Flora & Annette with with all their future ifsue and increase, I give & bequeath to my son John 3 Ravenel his heirs and afsigns forever my negroes Hector Esaw Catey and Hannah with the future if sue and increase of the females also one half of my Stock of Cattle Hogs and Sheep. I give and bequeath to my Daughter Catharine Ravenel her heirs and afsigns forever my negroes Richard Judy and William with the future ifsue and increase of Judy I give and bequeath to my grand son Henry William Ravenel his heirs and afsigns forever my negroes Amelia and Minus with the future ifsue and increase of

Amelia I give and bequeath to my aforenamed three Daughters Charlotte Maria & Catharine all my Mousehold furniture and plate, with the exception of the two Silver Tumblers before properties, all my Kitchen furniture my Carriage and Horses and my riding chair I also give to my said three Daughters Charlotte Maria and Catherine my House and Lot in Pineville as joint property and for their use so long as they shall remain Single, but/se my will and desire that each one of them on getting married shall forfeit all her right interest or title to any part of the said house and Lot and it shall be for the use of the single ones only, but should none of my aforesaid Single Daughters ever get married, at the death of the last Survivor of them then it is my will and desire that the aforesaid House and Lot be sold and the proceeds thereof be equally divided between all my other children or their heirs or afsigns for ever.
