Segare of Charleston and State aforesaid Widow,
being of sound Mind, Memory and Understand-
ing, but calling to recollection the uncertainty
of this life do make publish and ordain this
my last Will and Testament, that is to say,
first I commit my body to the Earth to receive
a Christian burial and in hopes of a joyfull
resurrection into eternal life through Jesus
Christ my blessed Lord and Saviour. It is my
desire that my Coffin be made of Cedar and
covered with superfine black broad Cloth and
lined with fine white flannel and instead of a
Pall that my friend Thomas Doughty do buy
three Yards of superfine black broad Cloth to
cover my Coffin with to the Grave, then to be
given to Job Palmer as for and concerning
the worldly Estate it has pleased God to bless
me with, I order and direct that therefrom all
my just debts and funeral expences be first
paid and satisfied by my Executors herein
after named, then a head and foot stones be
purchased here or sent for from Philadelphia
and that my friends Thomas Doughty or Ma-
ry Lamboll Thomas do see them set up and whi-
ever of such worldly Estate shall then remain I
will and dispose of the same in manner and

form following. It is my desire that my house in
King Street shall be sold and out of the money aris-
ing therefrom I give and bequeath to Frances Ma-
thens Wife of James Mathens and daughter of Thomas
Doughty and the heirs of her body for ever one hun-
dred pounds. I also give and bequeath to Mary Proach
and her brother John M. Gregor sixty pounds ster-
ling each and in case of the death of her said bro-
ther before he should attain the age of twenty one
years, then his right of claim shall descend to the
said Mary Proach and the heirs of her body for
ever, and the overplus remaining from the sale
of the said house after satisfying the above men-
tioned legacies, shall resort into the remainder
of my Estate and be appropriated towards pay-
ing the other legacies hereinafter bequeathed. I give
and bequeath to Frances Mathens and the heirs
of her body for ever all my Plate, and it is my
Will and desire that the said Frances Mathens
shall take into charge my Negro Girl Susy and
have the services of her for the space of ten years
from and after which time she shall be set free.
I give and bequeath to Mary Proach, Mary Scott
and Frances Mathens all my wearing apparel
to be equally divided between them share and
share alike. I give and bequeath to Mary Proach
and Elizabeth Stevens my blue and white table
China to be equally divided between them. I give
and bequeath to the said Mary Proach my black
carpet, New chairs and Sophy together with all the

63 furniture, China and Prints in my dressing
room as also my double Chest of drawers. I give
and bequeath to the said Mary Scott my half
Chest of drawers, dressing glass, bedstead and c^o Ma-
trap, my new suit of curtains, together with my
easy chair and the covers belonging to the same
and it is my Will and desire that she the said
Mary Scott shall have the services of my Negro
girls Rose and Susannah for the space of fifteen
years after my decease and from and after the
expiration of that time my Will further is that
they shall be manumitted and set free. I give
and bequeath to Daniel Legare all my books
and also the sum of one hundred pounds to be
paid him out of a bond given by Nathan Le-
gare to my deceased husband now in my po-
session, and I give and bequeath (after deducting
the above legacy) the remaining sum due on the
said bond to the said Nathan Legare as also
my Chaise, and it is my desire that ~~he~~ should
take into his possession and have the services
of my Wench Amoretta for the space of two
years and from and after that time she shall
be set free. I give and bequeath to Mary Dough-
ty my Carriage, and it is my Will and de-
sire that she shall have my Wench Hagar
and her three Children, Charles, Moses and
Peter for the space of four years and from and
after that time my Will further is and I do hereby
desire that they and each of them shall for ever
be manumitted and set free. I give and bequeath
to Sarah Legare Wife of Joseph Legare and Mar

24 Doughty the remainder of my furniture not here
in otherwise given and bequeathed to be equally
divided between them and it is my desire that
the said Joseph Legare shall have his Father
and Mother's Pictures. I give and bequeath to Ma-
ry Proach and the heirs of her body for ever my
Negro named Prince, my Will and desire is that
the Negroes named Jane and Nat shall be sold
and the monies arising from such sale ~~be~~ applied
towards paying the several legacies herein men-
tioned. I give and bequeath to my beloved friend
c Mary L Thomas, and her two daughters Mary
Beach and Elizabeth Thomas forty pounds ster-
ling each to buy them rings or any other token
of my love for them, and it is my Will and
desire that the said c Mary L Thomas may have
the bed, bolster and pillows that she gave me,
which I have laid upon ever since and insist she
shall take them, and in case of her death they
may be given to her said daughters and if they
will not take them then they may be given to
her Grand Children, the Children of the said
c Mary Beach and my Will further is and
I desire that the said c Mary L Thomas and
each of her said Children and Grand Children
shall have hoods and full mourning for me. I give
and bequeath to Ann Delaire and Elizabeth
Barton ten pounds sterling each with hoods,
gloves and fans as a token of my thankfulness
to them in my great affliction and sickness. I
give and bequeath to my friends Abigail Jones and

65 her daughter Martha Jones ten pounds sterling each with hoods and full mourning as a token of my love and esteem for them. It is my Will and desire that the house lately bought of George Wagner in c Marryck Street shall be sold and the money arising therefrom be appropriated to the following purposes, that is to say I give and bequeath to my beloved Son in law Joseph Legare and the heirs of his body for ever three hundred pounds sterling, to c Mary Doughty Wife of Thomas Doughty and the heirs of her body for ever two hundred pounds sterling, and to Sarah Webb daughter of John Webb forty pounds sterling and in case of her death without lawful issue, then it shall go to c Mary Condry and in case of the death of the said c Mary Condry then it shall go to Doughty Condry brother of the said Mary Condry. I give and bequeath to the Reverend Isaac Skeith one hundred pounds sterling the Reverend Richard Furman and Benjamin Palmer fifty pounds sterling each to be paid by my Executors as a token of my regard and respect for them. It is my Will and desire that from and immediately after my decease my Executors herein after named shall manumit, enfranchise and set free the following Negro slaves viz^t Tenez, Tom, Dick and Sue and I give and bequeath to the said Wench Tenez the sum of five pounds sterling and also a full suit of mourning. I give and bequeath to my Son in law Joseph Legare my Negroes Mary and Jacob to do with them as he may think proper. I have vowed a vow therefore I must perform it.

62 That is my house in Broad street which my heavenly Father gave me, I now return to the house of my Lord and it is my desire that it shall be sold or hired out as the Trustees of the Independent or Congregational Church of Charleston may see fit and the monies arising from such sale or hire to be appropriated to the following purposes that is to say, I give and bequeath to the Baptist fund for Educating and training up young Men for the Ministry the sum of one hundred pounds sterling and the remainder of the monies arising from the sale or hire of the said house, I give devise and bequeath to the Independent or Congregational Church of Charleston, whereof I am a member, in trust as a fund to be held and improved in the most secure and advantageous manner by the aforesaid Church for ever, for the following purpose that is to say, it is my Will and pleasure that the whole clear income of the aforesaid fund be employed by the said Church towards furnishing the means of obtaining a suitable Education for the Gospel Ministry to some person or persons holding the Doctrines of Grace as they are taught in the holy scriptures and stated and explained in the confession of faith and larger and shorter Catechisms composed by the Westminster assembly of Divines and possessing talents and supporting a character for piety and virtue which be approved of by the said Church and whose worldly circumstances would not conveniently allow him or them to acquire such an Education at his or their own expence. It is my desire that my Executors do deliver up to the Grand Children of my deceased husband Daniel Legare or their full Guardians the three indentures now in my possession amounting to three thousand three hun.

dred and twenty four dollars seven cents which in-
debits came into my hands as being entitled to the
interest growing due thereon during the term of
my natural life and then the principal thereof
to become the property of his Grand Children. And
after paying the before mentioned legatees if the
funds of my Estate will hold out, I then give and
bequeath to Sarah M. Calla Wife of Doctor M. Cal-
la, Elizabeth Stevens, Elizabeth Condry Wife of
Jeremiah Condry, Ann Legare and Mabel
Legare daughters of Nathan Legare, Mary Le-
gare and Susannah Legare daughters of Jo-
seph and Joseph Legare Son of Joseph the sum
of ten pounds sterling each as a token of my
love. And I give and bequeath one half of the
residue of my Estate if any there should be to
Joseph Legare of Santee and the heirs of his body
for ever and the other half to Mary Doughty
and the heirs of her body for ever. And lastly I
do hereby nominate constitute and appoint my
dear Son in law Joseph Legare of Santee
and my beloved friend Thomas Doughty
of Charleston Executors of this my last Will
and Testament, revoking and making null
and void all former and other Wills by me
heretofore made and declaring this only to be
and contain my last Will and Testament. In
Witness whereof I have hereunto set my hand
and seal this third day of November in the Year
of our Lord one thousand eight hundred and in
the twenty fifth Year of American Independence.
I give and bequeath to Thomas Jones my horse.

Testator to be and contain her last Will and Testa-

ment in the presence of us, who in her presence, at her request, and in the presence of each other subscribed our names as Witnesses to the due execution thereof, the words "shall be" in the 31st line 2^d page being first erased and the words "together with all the furniture China and prints in my dining room 2^d page 2^d line" being first interlined, and the words "and horses 18 line 2^d page" erased. And the bequest at the end of the Will was inserted at the time of signing it.

I give and bequeath unto my loving daughter Ann Waring three certificates or indents in my name of the funded debt of the United States, amounting in the whole to three hundred and fifty dollars ⁴⁰⁰ viz one numbered 562 for 159 dollars ⁴⁰⁰, and one other numbered 393 for 56 dollars ⁴⁰⁰ both bearing the interest of six per centum per annum and one num
