after my decease, do make ordain and publish this my last
Will and Testament hereby revoking all other wills or instruments
of writing by me heretofore made. And as it will be necessary for
some person or persons to be appointed by me to carry into effect this
my last Will after I shall have ceased to be mortal it is my wish
that my Son James B. Edwards, ^{John's heirs} carry this my will into execution
in the character of Manager. In the first place it is my wish
that all my lawful debts and funeral expenses be paid. 2.^d I give and
bequeath to my daughter Mrs Taylor Five pounds Sterling money
to be paid her twelve months after my decease 3. I give and bequeath
unto my daughter Elizabeth Bristow two negro children named
Lucy and Bob also all my Stock of cattle & all of my household and
Kitchen furniture not hereinafter named also one bag mare
named May and all the Poultry in my yard. 4.th I give and
bequeath unto my Son James B. Edwards one negro wench named
miley, the plantation or tract of Land I now live on also one
other tract of pine land lying on Pigeon pond also my two
horses named prince and flip one Feather Bed and furniture
I want the wench and Son

married Mary and all the Poultry in my yard. 4.th I give and bequeath unto my Son James B. Edwards one negro wench named mily, the plantation or tract of Land I now live on also one other tract of pine land lying on Pigeon pond also my two horses named prince and flip one Feather Bed and furniture and my Rifle Gun. 5.th I give and bequeath unto my Son Samuel Edwards one negro man named Glasgow one Bed and furniture one double barreled Gun and one Musket 6.th I give and bequeath unto my daughter Mary Thornly one negro wench named Fanny and one colt. 7.th It is my desire that all my Barrows & Spade Saws and all my Stock of Sheep be sold to pay my debts. It is also my desire that all my provisions be kept on the plantation for plantations use as also my waggon and hand mill 8.th I give and bequeath to my Son Samuel Edwards in addition to the above named property three tracts or parcels of land to the Eastward end of Pigeon pond containing in the whole eighteen hundred acres. In witness whereof I call Gods to witness this fourteenth day of November in the year of our Lord Blessed Lord and Redeemer One thousand eight hundred and Seventeen and hereunto set my hand and affixed my Seal
