deed of settlement, made after my marriage with the said Joseph, my present hus-
band, bearing date the thirteenth day of April, in the year of our Lord, one thou-
sand eight hundred and twenty two, between the parties thereto, the said Joseph

other powers and authorities whatsoever to me given or reserved as follows, namely
after paying the sum of one thousand Dollars, bequeathed by the Will of my

And I declare that the said Peter Poirier, or any new trustee, who shall be substituted, shall not be accountable, any otherwise than each person for his own actual receipts and Willful defaults. And after the death of my said sister, my will is that the shares, or stock so held for the purposes aforesaid, go to my husband, the said Joseph D. Ravina, and his heirs absolutely and without incumbrance. I also give and devise to my husband the said Joseph D. Ravina, all that meeuage and tenement situate in Queen Street in the City of Charleston.
