heavy losses in business and is now in ~~embarrassed~~ & straitened
circumstances and I am desirous as far as in me lies to
make some provision for him of which in the event of my death
he cannot be deprived and which cannot be in any man-
ner subject to his debts or engagements and which provision
in the event of his endeavouring to mortgage pledge or
in any manner to anticipate the same should immediately
pass from him to my legatees and devisees next entitled to it
and with the view if possible of attaining this object I give
devise & bequeath direct limit & appoint the House lot and
premises in Broad Street conveyed by the said Trust deed
do hereby

as by reference thereto will fully appear do make public
and declare this my last will & Testament in manner
and form following that is to say Inprimis. My dear
Husband has thro the facility of his disposition and his
desire to accomodate and assist others suffered many
heavy losses in business and is now in embarrassed & straitened
circumstances and I am desirous as far as in me lies to
make some provision for him of which in the event of my death
he cannot be deprived and which cannot be in any man-
ner subject to his debts or engagements and which provision
in the event of his endeavouring to mortgage pledge or
in any manner to anticipate the same should immediately
pass from him to my legatees and devisees next entitled to
and with the view if possible of attaining this object I give
devise & bequeath direct him to appoint the House lot and
premises in Broad Street conveyed by the said Trust deed
for my use and subject to my disposition unto my dear
Husband Charles Kiddell for and during his natural
life on the express condition that he the said Charles Kiddell
should under no circumstances sell assign transfer pledge
mortgage or dispose of the income arising from the said
lot and premises or any part thereof by anticipation or
in any manner whereby or in which he should authorize
or empower or intend to authorize and empower any

person or persons whomsoever to receive such income or any
part thereof otherwise than for his the said Charles Kiddell's
direct and immediate use the same being intended by me
to provide so far as the same may extend a secure and certain
personal maintenance for my said husband. And if at
any time or times thereafter the operation of any Bankrupt
or Insolvent Law or any act matter or thing in Law or Equity
without or with the will and consent of my said husband
would deprive him my said husband of the income or
enjoyment of the said Lot and premises, or if he my said
husband shall sign any instrument whereby or in which
he shall assign transfer pledge mortgage or otherwise
part with or shall contract or agree to sell assign transfer
pledge mortgage or otherwise to part with the said income
or enjoyment of the said lot & premises or any part thereof
as a security for any sum or sums of money due or
owing by him or to be lent and advanced to him by any
person or persons whomsoever or in any manner what
soever charge or dispose of the said income and enjoy-
ment of the said Lot and premises or any part thereof
by way of anticipation or wherein or whereby he should
authorize or empower any person or persons ^{or intend to authorize or empower any person or persons} whomsoever
to have receive or possess the said Income or enjoyment of
the said lot and premises otherwise than for his my said

Husband's own direct & immediate use, then and in all
or in any or either of these cases I from thenceforth entirely
annul and revoke this gift devise bequest, direction limitation
and appointment and the same shall cease determine
be and become absolutely null & void and I will order and
direct that the said House & lot and premises shall
immediately go and pass to the person or persons next entitled
to the said House Lot and premises, under this will and
upon the death of my said Husband or other sooner determi-
nation of his Estate in the said lot & premises then I
give devise bequeath direct limit and appoint the said
lot of land & premises unto my six Children - Caroline &
Scott formerly Kiddell Mary Anna Kiddell Benjamin
& Kiddell Charles Kiddell the younger George Kiddell
and Charlotte W Kiddell to them their heirs and assigns
forever to be equally divided among them share & share-
alike and should any or either of my said six Children
die before the death of their Father the said Charles Kiddell
or before the other sooner determination of his Estate in the
said lot & premises without leaving lawfully begotten
issue living at the time of his death or their my said
child or Children's death to live until the death of the
said Charles Kiddell or the other sooner determination

of this Estate in the said lot & premises then as to the share
 or shares in the said lot and premises of such Child or
 children so dying as aforesaid I give devise & bequeath
 direct limit and appoint full power & authority to the
 said Charles Kiddell to direct limit & appoint such
 share or shares of such Child or children so dying
 as aforesaid between and among our surviving children
 or to such one or more of them in such manner and
 under such limitations conditions and provisos as he
 may think proper and for want of such direction
 limitation and appointment by the said Charles
 Kiddell then the said share or shares of the said Child or
 children so dying as aforesaid shall go to and be divided
 among our surviving children share and share alike
 the children of any deceased child taking and receiving
 all ways the share or proportion to which the parent or
 parents if alive, would have been entitled Lastly I hereby
 nominate constitute and appoint my dear husband
 Charles Kiddell to be Executor of this my last will &
 Testament In witness whereof I have hereunto set
