I give and bequeath unto my God Daughter Mary Capdeville in this City one half of the two fifths remaining, the other fifth I desire may be applied to Liquidate a debt due to Louis Duboug late resident in the Cape at St Domingo, but should it not be claimed I then direct my Executors hereinafter named to pay out the said ....
