Myrtilla to have and to hold the same unto them their Ex-
ecutors and Administrators subject to the following trusts
uses intents & purposes following that is to say my said
Executors within named are to hire out the said five Slaves
and receive the wages and profits arising from their Labour
and Services and to appropriate them in the following man-

female slave Sarah Martha until She shall arrive- at the age of twenty one years and the rest of the said wages and profits arising from the labour and Services of the aforesaid five Slaves to be invested by my said Executors in Bank Stock or in Stock of this State or the United States as may be most advantageous and to be paid to the said Sarah Martha on her arriving at the age of twenty one years, but should the said Sarah Martha depart this Life before she arrives at the age of twenty one years then it is my will and desire that the wages & profits arising from the Labour and Services of the aforesaid five Slaves be applied to the support and maintenance of my aforesaid female slave Sarai the grand mother of the said Sarah Martha until such times as the said Sarah Martha had she been living would have arrived at the age of twenty one years. And it is my further will and desire that after the said Sarah Martha shall arrive at the said age of twenty one years, or after the time that the said Sarah Martha (should she depart this Life before arriving at the Said age) had she been alive would have arrived at the Said age of twenty one years, my Executors their heirs Executors and administrators do allow and permit the Said five negro slaves viz^t Phoeby Amey Sukey her son Peter and Myrtilla to receive and retain the wages and profits of their labour and services to their and their only several uses and behoof without any manner of molestation or hindrance whatsoever and further that they will emancipate and set them free from Slavery as soon as it may be legal to do so, or if it should not be legal to emancipate them then that they will allow them at any and at all times to depart from this State and to return to the Same if it shall be Lawful Item I do give devise and bequeath unto my beloved Son in Law Doctor Anthony V. Toomer all the rest and residue of my Estate real & personal whatsoever and where-

soever to him his heirs executors & administrators forever.
And I do nominate and appoint my beloved Son in Law Doctor
Anthony V. Toomer and Thomas D Condy Executors of this my
Last Will and testament. In Witnefs whereof I have here-
unto set my hand and Seal at Charleston in the State afore-
said this fifteenth day of June one thousand eight hundred
and twenty one.
