In the event of her behaving well and serving out her time faithfully but not otherwise.

I request and direct my Executors, as soon after my decease as it can be conveniently and lawfully done, to emancipate from slavery in

52. form of law, at the expense of my Estate (to which expense I hereby subject it) my Servants Peggy, Amelia, Margaret and Sophy, the two last named being the children of Amelia. the rest of my Slaves, I give and bequeath to my niece Sarah Parker Scott, her Executors, administrators and assigns. Item I give and bequeath one moiety of the rest and residue of my Estate, (excepting as hereinafter excepted) unto my said niece her executors, administrators and assigns: Item the other moiety of my Estate with the exception as aforesaid, I give and bequeath unto my Brother Thomas Parker, his Executors, administrators and assigns in gratitude for his Kindness to my Sister and myself, and as a compensation, as far as it may go, for the anxiety, trouble and labor he has experienced in his management of the Estate of my Father. Item I give and bequeath all my plate to my niece Maria Eveline Winthrop, her executors, administrators and assigns, as a remembrance of me, Item, I give and bequeath all my apparel & furniture to my niece Sarah Parker Scott, her executors, administrators and assigns. Lastly I constitute and appoint my said brother Thomas Parker and my nephew Thomas Parker Junior, Executors of this my last Will and Testament hereby revoking all and

his Kindness to my Sister and myself, and as a compensation, as far as it may go, for the anxiety, trouble and loss he has experienced in his management of the Estate of my Father. Item I give and bequeath all my plate to my niece Maria Cordina Winthrop, her executors, administrators and assigns, as a remembrance of me, Item, I give and bequeath all my apparel & furniture to my niece Sarah Parker Scott, her executors, administrators and assigns. Lastly I constitute and appoint my said brother Thomas Parker and my nephew Thomas Parker Junior, Executors of this my last Will and Testament hereby revoking all and every other will by me made heretofore made.
