Worldly Real and Personal Estate wherewith it hath pleased God to
intrust me. I dispose of the Same as follows. I give and bequeath that is
to say I wish that all my just Debts shall be paid in Charleston State of
South Carolina and I do hereby appoint Josiah Parks my Executor to Sell
and dispose of all my personal property in the City of Charleston State
aforesaid and to remit the proceeds of my Said Personal Estate (after
my just debts are paid in Charleston aforesaid) to my Executors & other
Executors hereafter named to say I do hereby nominate and appoint my Wife
Sarah Allen Executrix and my Brother Samuel Allen (both of Washing-
ton Dutchess County State of New York) Executors of this my last Will
and Testament and it is my wish that my Said Executrix and Executor
Samuel Allen do dispose of Sell and Sell all my Real and personal
property in the State of New York that I may die possessed of at the time
of my decease to be disposed of to the best Advantage first paying all

me heretofore made and do declare this to be my last Will & Testament
at Charleston the twenty second day of April one thousand eight hundred
and twenty two

and annul all former Will or Wills by me wrote or signed and do
declare this to be my last Will in Witness of which I subscribe my name
authorising the above Will and Testament to be registered in the proper
Court in the States of America according as laws direct, wrote and signed
in Charleston this tenth day of April one thousand eight hundred and
