I have as I am seized or possessed of I bequeath to my said Children as
aforesaid. And do hereby constitute and appoint my Son in Law
Michael Kelly my Sole Executor of this my last Will and Testament
and do likewise hereby utterly revoke disallow and disannul all former
bequest Wills and Legacies by me heretofore in any wise left or made declar-
ing ratifying and Confirming this and no other to be my last Will
and Testament In Witness Whereof I have hereunto set my Hand &
Seal this twelfth day of September 1820. Susannah Baker (L)
