charged: All and singular the above Legacies, which I have given
devised and bequeathed to my said wife, I do by this my Will de-
clare to be in lieu and stead of all manner of dower, distribution
Share, or any further claims or demands whatever, which she
my said wife can or may have on out of or against my Estate
either real or personal after my decease. I give ^{bequeath} unto my Son
Elias Hony all my furniture, plate, liquors, Carriages, Horses,
and Stock of whatever kind the same may be, on my plantations
on Santee River: Also my Mahogany Chest now in my
House in Charleston, in which all my deeds and papers are
kept, together with the monies and every thing whatever which
may be in the said Chest; to hold to him his Executors, adminis-
trators and assigns forever: & all the rest, residue and remainder
of my Lands and other real and Estate, I give and devise unto my
Son Elias Hony his heirs and assigns forever: Also I give and bequeath
to my said Son all the rest, residue and remainder of my personal

Also I give and bequeath to my said Son all the rest, residue and remainder of my negroes, and the future issue and increase of the females of them, and the remainder of my other personal property Estate, to him, his Executors, administrators and assigns forever. I do hereby nominate and appoint my beloved wife Ann Hony Executrix during her Widowhood and no longer, and my Son Elias Hony Executor of this my last Will and Testament. I do hereby revoke all former Wills and Testaments, by me heretofore made, and I declare this to be my last. By this my Will, I enjoin my Son never to become bound in any manner whatever, as a security. In witness whereof I have hereunto set my Hand and seal this twenty third day of June in the year of our Lord One thousand eight hundred and ten /1810/—
