 further build & furniture as also one Negro Girl called Patsy
 the sum of one hundred & fifty pounds cur. Money of Carolina
 to be paid her when she shall attain to the age of Eighteen
 years or day of Marriage w^{ch} shall first happen.

Item I Will that my Plantation w^{ch} lies of the Town on Cooper River
 the Stock in the same I Order & Do Impower my Execut^r thereafter
 to sell & Dispose of the same & y^e Moneys arising by y^e said things
 to be Equally Divided between my 3^d Daughters w^{ch} I divided so
 paid to them shall be Reckon'd & deemed to be part of y^e said one
 hundred & fifty pounds already & Bequeathed them y^e Remaining
 part of w^{ch} said sum of one hundred & fifty pounds shall be paid
 to my said Daughters by their said Brothers out of their portions
 they shall come & Attaine to the age aforesaid or day of Marriage each
 of them to be maintained out of y^e whole Stock to the time aforesaid
 I will also that if either of my said Sons or Daughters dye before
 they come to y^e age of Eighteen years or when attained to y^e said age
 shall dye without Lawfull Issue begotten of their bodies then I
 will that that part or portion of any of them so Deceased to be Equally
 Divided amongst y^e Surviving of them.

Item I Give & Bequeath to my said wife Elizabeth Collins one full
 hard part of all my whole Estate whether y^e same be Negro
 horses Cattle, Stock & household stuff whatsoever and all y^e rest
 of my Negroes, horses, Cattle Stock & household stuff soever shall
 be Equally Divided amongst my said three Sons, I will also that
 my Sons John & Alexander & also my Daughter Jane that their sever
 parts & portion be under y^e Care & Management of my said wife
 till they severally arrive to y^e age of Eighteen years or that my
 Daughter be married w^{ch} y^e my said Son Jonah to have y^e part &
 portion of my Daughter Elizabeth under his Care & Management
 till she arrive to y^e age of Eighteen years or day of Marriage
 w^{ch} of the two shall first happen & y^e my 3^d Son do maintain them.

Item I Do constitute & appoint my 3^d wife Elizabeth Collins my Execut^r
 & my 3^d Son Jonah Execut^r of this my last will & Testament.

Lastly

By these Writs Revoked Renounce frustrate & make void
 all former Wills & Testaments by me heretofore made & Declared
 & appoint this to be my Last will & Testament. Witness the hand
 of the said John Collins hereunto set my hand & seal at Charleston
 Town this 13th day of August 1757 years of our Lord one thousand
 seven hundred & seven.
