

In Name of God Amen, twenty third Day of November & year of our Lord on thousand six hundred Ninety Seven Jonathan Amory of the Province of Carolina Merchant being sick in Body yet of sound and perfect Memory made be God to make this my Last Will & Testament in manner here following That I do Bequeath my lands & parts into the hands of Abraham God my heavenly Father my body to be buried as I desire in any town or city & my worldly Estate to be divided as follows I give & bequeath unto my son Joseph Crasky all y^e Piece of Land that lyeth next y^e Bratt rapps it was bought of Andrew Lawson & lyeth in y^e hands of y^e Brand pack as you goe in to y^e town where he is a Partner for rent I likewise require my executors to make y^e Division of y^e piece of Land which lyeth next to my dwelling house which I gave to him with my Daughter I also give him my best Silver beaded Gowne I give to Sarah my Daughter 20 Bags of White Indian Corn I give y^e hands of Mother & buy her a Gold Chain I give to Sarah Ann Williamson 1000 Lounds I give unto David Jones 1000 Lounds I give to y^e Poor of Charles Town 50000 Lounds I give & bequeath to Thomas Hobbs Twenty Lounds I give unto my Loving Wife Martha my Dwelling house in Charles Towne wally Land wally in about y^e same during her Natural Life after her Death I give & grant a Twelve y^e House & Land to my sons Thomas and Robert Amory & y^e survivors of them that live & a bequest for ever I give & bequeath unto my Loving Wife at her Waring Answer all y^e Silver & Jewels that shee belonging to my Dwelling House I give & bequeath unto my Daughter Sarah Amory y^e Sum of three hundred Lounds & to my Daughter Ann y^e like Sum of three hundred Lounds All y^e rest and residue of my Estate both real & Personal in this World I give & grant to my Loving Wife Martha and my sons Thomas & Robert Amory to be equally Divided between them share & share alike. I also Nominate and Appoint

my said Wife Martha sole executrix during her Life & after her Decease I Nominate and Appoint my two sons Thomas & Robert my Executors I Do also Improve and Authorize my Executrix to sell y^e Estate forever all or any part of my real Estate & provided that the Names of y^e Executors named thereby be Secured to my Love & Honor The Witnesses Whereof I have hereunto set my hand and Seal day year & place above Express
