Satisfaction To make Dcharges As occasion Shall Require Giving & to the
present Granting unto y^e said Capt^r Edward Archer full power & authority in
premises Therein to deale do & Execute & To Acquit Release & Discharge &
Contract & agree in as large & ample manner as if he & S^r John Vole were
personally Present before y^e said John Vole promising to Ratify & confirm
all & every Act & thing Which Wee or any under us shall do in or about y^e

Wife apperteyning to me the said Joan Battin for What cause or by what
Means soever Nothing Excepted nor Recurree Also to C^r Examine settle
and adjust the Accounts and y^e Doallame to Receive and upon Receipt
thereof to give full & sufficient Dcharges and equifances in due forme of
Land and if need be to sue to appear before all Land judges & Justices
in any Court or Courts to do say pursue plead Seize Sequester Attach
Imprison & out of prison to Discharge & to substitute & Appoint
one or more attorney or attorneys in any of y^e places & y^e same
Against my pleasure to Revoke & Generally in & about the premises to
do all & Whatsoever is requisite as fully as y^e said Joan Battin might
or could do if I were personally present in my self whereof I have here
unto putt my hand & Seal this day of
1703
