 arrest, sue, prosecute and impleade for & of same, & to compromise, conclude,
 agree, recover and receive, & upon such recovery & Receipt of the prem
 ises or any part thereof, or Composition or other & thereof to be made,
 Acquittances or other discharges for & same in my name to make, & one
 Attorney there, under him, for more to make & substitute, and generally to
 doe, Execute, prosecute and performe all & every such further & other
 lawfull act & acts, thing or things whatsoever, it in or about the prem
 ises shall be needfull necessary or convenient to be done as fully & effectu
 as myself might or could doe Howling and allowing for sume &
 effectual all & whatsoever my S^r Attorney his Substitute, or Assign
 shall Lawfully doe or cause to be Done in or about the premises
