Know all men by these Presents that Anne Williamson Widd^{ow} Relict and Execut^{rix} of Sam^l Williamson late of this Province Vintner Deed for divers good Causes and Considerations me hereunto moving but more Especially for the Considerations hereafter mentioned Do Give unto my Negro man by name Tikey his freedom Immediately after the Expiration of four years commencing from the Date of these presents And I do hereby irrevocably Declare that the said Tikey shall be a free man to all Intents and purposes so soon as y^e said Term of four years shall be Expired Provided always and it is my true Intent and meaning that if my said Negro man Tikey shall at any time within the said Term of four years be lawfully Convicted before any Justice of the peace of any Misdemeanour done or Committed to me in Respect of his not obeying or working for me honestly y^e said Term then these presents to be void and of none Effect as if y^e same had never been made otherwise to be in full force and Virtue In Witness whereof I have hereunto putt my hand and Seale the Eleventh day of May Anno 1702

 being accomplished the other two to stand void and so God
 send the good Ship to her desired Port in Safety Amen

This Indenture made in the four & twentieth day of January in the first year
 of our Lady Ann Queen of England in Annoq^{uo} dom. 1702 Between Elizabeth Rind
 late of Hellingdon p^{er} in Midd^{le}sex of the one part and J^{no} Wright of Savoy
 Planter of the other part Witnesseth that y^e said Elizabeth in the presence of Alex^r
 Harris Esq^r Justice of y^e peace hath & by these presents doth bind & put her selfe an
 Apprentice & servant to y^e said J^{no} Wright to serve him or his assigns in the plantation of veng
 or Anguilla beyond Seas for y^e space of six years next ensuing y^e arrival of y^e said
 servant in any of y^e said Plantations, And heretofore Covenant not and truly to ser
 vice y^e Master or his lawfull assigns in the said Plantations for & during y^e said term
 according to the laws & customs of y^e said Plantation and doth further declare an
 Covenant that the said servant at the time of y^e Enfoaling heretofore, is of the age of
 Eighteen years, a single Person And no Covenant, or contracted servant to an
 Person or Persons, And y^e said Master for himselfe his Executors & assigns in con
 sideration thereof doth heretofore Covenant, & agree to and with his said servant y^e he
 said Master shall & will, or his Assigns at his or their own proper costs & man
 w^{er} what convenient speed they may carry & convey or cause to be carried
 conveyed over to y^e said Plantation his said servant & from thence forth to dwell

the said Voyage and also during the said term shall & will at y^e like cost and
 provide for and allow his said servant all necessaries fit and convenient for her
 according to the Custom of the said Plantation and another servants in such rates
 are usually provided for & allowed In witness whereof the said parties have here
 unto set their hands and seals the day and year above written
