unto my Negro man by name Tikey his freedome Immediately after
the Expiration of four years Commenceing from the Date of
these presents And do hereby irrevocably Declare that the said
Tikey shall be a free man to all Intents and purposes so long
as y' said Term of four years shall be Expired Provided
always and it is my true Intent and meaning that if my
Said Negro man Tikey shall att any time within the said
Term of four years be lawfully Convicted before any Justice
of the peace of any Misdemeanour done or Committed to me
in Respect of his not obeying or working for me honestly
Said Term Then these presents to be void and of none effect
as if y' same had never been made otherwise to be in full
force and Virtue In Witness whereof I have hereunto
put my hand and Seale the Eleventh day of May Anno

This Indenture made in the four & twentieth day of January in the first year
of our Lady Ann Queen of England &c Annoq^d Dom 1702 Between Elizabeth huse
late of Hollingdon y^e In Midd^r Spinster of the one part and Mr Wright of Carrol^{ton}
Master of the other part Witnesseth that y^e d^r Elizabeth in the presence of Alex^{ander}
huse Esq^r Justice of y^e Peace hath by those premises d^r bind^d to put her self an^d
servant to y^e d^r Mr to serve him or his assigns in his plantation of vry
or Pensilvania beyond seas for y^e Space of six years next ensuing y^e annv^r of y^e So
servant in any of y^e d^r Plantations, and herby Covenant well and truly to serve
her y^e d^r Master or his lawfull assigns in his y^e d^r Plantations for or during y^e d^r ten
according to the laws & customs of y^e d^r Plantation and both further declare an^d
Covenant that the y^e d^r Servant at the time of y^e d^r indenting hereof, is of the age of
Eighteen years, a single Person and no Covenanted or contracted Servant to an^d
Person or Persons, And if y^e d^r Master for himself, his Executors & Assigns in conju^r
tation therof doth hereby Covenant, to agree to and with his y^e d^r Servant y^e d^r
y^e d^r Master, shall & will, or his Assigns at his or their own proper costs & charges
what convenient speed they may carry in Convoy or Caus^d to be carried
Conveyed over to y^e d^r Plantation his y^e d^r Servt^d from thence forth & during

the y^e d^r Voyage and also during his y^e d^r term shall be well all y^e d^r like cost and
provid^d for and allow his y^e d^r Servt^d all necessaries fit and convenient for him
according to the custom of the y^e d^r Plantation and as other Servants in sum value
and usage provided for or allowed. In witness whereof the y^e d^r Partys have here
