 to me in hand at and before y^e Enrolling & Delivery
 of these Pres. well and truly satisfied. Underlast Seal
 of John Alexander of Charles Town in y^e P. Province
 Heret. the Receipt whereof I do hereby acknowledge
 have given, granted, assigned & sold, and by these Pres.
 do fully, truly & absolutely give, grant, assign & sell
 in plain and open Market unto y^e P. John Alexander
 one Negro-man by Name Dick and one Negro-woman by
 Name Nanny. To have & to hold y^e Negro
 man and Negro Woman to y^e P. John Alexander his Execut.
 Administrat. or Assignes as his & their own proper good &
 benefit and to this & their own proper use, Benefit and
 behoof for ever. Provided allwaile and it is
 covenanted & agreed by and between y^e Parties to these
 Pres. that if y^e P. Ellen Barlycorn her Execut.
 Administrat. or Assignes or any of them do well and
 truly content & pay or cause to be contented & paid
 to y^e P. John Alexander his Execut. Administrat. or
 Assignes the full & just Sum of Thirty Pounds in
 Dollars or Spanish Pieces of Eight weighing at least
 Thirteen Pennyweight at Five Shillings each Dollar or piece
 of Eight at, on or before the y^e 1st day of January next
 ensuing the date hereof without fraud or farther
 delay, then this Pres. Deed of Sale to be void and of none
 Effect. But if default or default of y^e P. Ellen
 Barlycorn in part or in all be made before the 1st Ellen
 Barlycorn my Execut. Administrat. or Assignes on y^e 1st day and
 year afores. contrary to y^e Form afores. that then y^e P. Ellen
 Barlycorn my Execut. Administrat. or Assignes every of us
 shall & will lawfully & for ever defend the P. Negro before
 herein bargained & sold & every one of them unto y^e P.
 John Alexander his Execut. Administrat. or Assignes against all
 Defens. by these Pres. Notwithstanding whereof I have hereunto
 set my hand & seal y^e second day of Jan. Anno Domini 1630
