Acquittances or other sufficient Discharges for me & in my name to make Seal & deliver And Generally all & every other Act & Act thing & things Devis & Devices in y^e Law whatsoever needfull & necessary to be done in and about y^e premises for y^e recovery of all such Debts or sums of money afores^d. for me & in my name to do Execute & perform as fully largely & amply to all Intent & purposes as I myself might or could do if I was personally present or as if y^e matter required more special Authority than is herein contained And Attorneys one or more under him for y^e purposes afores^d. to make & Execute & again at pleasure to revoke, Ratifying Allowing & holding for firm and effectuall all & whatsoever my said Attorney shall lawfully do in & about y^e premises by Virtue hereof In Witness whereof I have hereunto set my hand & Seal y^e thirty first day of March Anno D^e 1701
