other Estate whatsoever, w^{ch} is, are or hereafter shall be due, owing
belonging or appertaining unto me by any manner of Way or ways
whether, & upon Recovery, & Receipt thereof to give true Discharge
in Discharges I may need by to appear & y^e Person of me the
assigns to Assigns before any Judges, Justices or Ministers
of the Law in any Court or Courts of Record and there in any
Petition to Assigns, Demand & Receipt to all Actions, Suits and

and holding Term & valid all & wherever my Assigns or his Assigns
shall lawfully do or cause to be done in & about the Premises by virtue

Eleventh Year of y^e Reign of our Sovereign Lord King William
the third over England &c.
