Arrest, Imprison, Implead & Prosecute for y^e same & upon such
Suit to proceed to Judgm^t & Execution & thereupon y^e Robert Daniell
his Execut^r and Administrat^r in Prison to hold & Keep until
thereof be made wth all Costs & Damages sustained & to be suffered
by Reason of Detaining y^e same And upon Paym^t thereof
the y^e Robert Daniell his Execut^r & Administrat^r forth of Prison
to Discharge and Acquittance for y^e same or any Part thereof for
me and in my Name, to make, Seal & Deliver and also to do
Perform & Execute all & every other lawfull & reasonable Act &
Act wthsoever both for Obeying & Discharging of y^e same
as shall be needfull to be done Giving & by these Pres^{ts} granting

to and with y^e said George Logan his Executors Administrators and
Assignes that it shall and may be Lawfull to and for y^e said George
Logan his Executors Administrators & Assignes from time to time
and at all times hereafter peaceably & Quietly to have hold use
& Employ y^e said Negro Man without any Lett Suit Troubles &
Molestation or Interruption of me y^e said John Hook or of any
other Person or Persons whatsoever Claiming by from or under
me And partly by y^e said John Hook do Covenant & Agree to and
with y^e said George Logan that I am the true and Right Owner
of y^e said Negro Man and that I have in my self full power and
Lawfull Authority to Grant Bargain & Sell y^e said Negro to y^e
said George Logan his Executors Administrators & Assignes for ever
and that I shall and will War: & for ever Defend y^e said Negro
man to y^e said George Logan Against all and all Manner of persons
Whatsoever In Witness whereof I have hereunto Set my hand
and Seal the Seventh Day of Sept: Anno Dom: 1699
