to my said Attorney my sole & full Power & Authority to Sue Suit
Implead, Imprison & condemn y^e said Francis Fiddling or any other
Person or Persons Treating or being indebted to me in any Sum or Sums
of Money their heirs Executors or Admors & against out of Prison
to Deliver at his Discretion & upon y^e receipt of any such Sum or
Sums of Money due unto me y^e said John Rule of Francis Fiddling
or any other Person to give a legal Acquittance or Acquittances & Discharge
a Discharge for me & in my Name to make, Sign, Seal & Deliver, and
again at his Pleasure to Revoke & further to Execute Perform and
finish for me & in my Name all & singular things & things w^{ch}
shall or may be necessary touching & concerning y^e Premises as
fully, thoroughly & entirely as if y^e said John Rule in my own Person
might or could do in or about y^e same ratifying, allowing & confirming
whatsoever my Attorney shall lawfully do & cause to be done in the

trusty & absolute Attorney for me & in my Name & for my use & behoof & to receive due
Presents any Sum or Sums whatsoever that shall demand or keep my said James
Peartree according to an Act of Parliament in that Case made & provided & do deliver
unto my said Attorney an Indenture Signed & Sealed by my said Servant James
Peartree aforesaid. And if any Person or Persons whatsoever shall refuse to deliver him or
to my said Attorney & him to prosecute to y^e utmost as y^e Law do direct & to dispose
of my said Servant for all y^e rest & residue of y^e time as y^e Indentures expressed
according to y^e manner & Custom of Carolina, And further I do Impower my
said Attorney to ask demand, recover & receive of Thomas Jackson Esq^r Place
aforesaid all such Money which is now due or which any time hereafter may
become due to me y^e said Richard Raddick & upon refusal, sequestrall or non
payment thereof to Sue Arrest & in Prison to put & him upon full Payment and
satisfaction made to my Attorney out of Prison to release & full & ample Acquittance
& discharge to Sign, Seal & give & every Act & thing to do & perform as fully
& amply to all Intents & Purposes as if my said Servant were personally present & one
Attorney or more to Substitute & at Pleasure to revoke hereby ratifying &
Confirming all & whatsoever my said Attorney shall do or cause to be done in
y^e Premises to both y^e Parties in these presents Specified In Witness whereof
I have hereunto set my hand & Seal y^e Nineteenth day of March Anno Dom. 1700
