 or appertaining unto me by any manner of Ways or means whatsoever
 within a Province aforesaid giving & hereby granting unto my Attorney
 by the Genes of these presents my full & whole power strength & Authority
 in & about the Premises And upon Receipt of any such debts Sums of money
 Goods Wares & Merchandizes aforesaid Receipts or other Discharge for me
 & in my name to make Release Discharge and Every other Act & Act thing &
 things Device & Devices by Law what so ever needfull & necessary to be done
 in & about the Premises for me & in my name to do Execute & perform
 as fully Lawfully & amply in Every respect to all intents & purposes
 as & my self might or could do if I were personally present & being
 allowing & holding Firm & Stable all & what so ever my Attorney shall
 Lawfully do or cause to be done in and about the Execution in and
 about the Execution of the same by virtue of these presents in Witness
