Receive, Account, adjust & coin Act. Comptrolr. Inclusive & agree by Arbitration
or otherwise as y matter shall require, and upon recovery & receipt thereof to
give due Acquittances & Discharges, and if need be to appear and if Person of any
Constituent to represent before any Governor, Judge, Justice, or Ministers of y Law
in any Court or Courts of y said Province there in my behalf to answer defend and
Reply to All Actions matters & things relating to y premises & otherwise lawfully
due to the said Person or Persons, to sue, prosecute, defend, Implead, Jurymen & Jurymen
out of Prison again when need shall be to deliver, or able to suffer in Law in
most ample manner until definitive sentence, with full power to make and
Substitute one or more Attorneys under him my said Attorney & y same again
at pleasure to break, and Generally in, touching & concerning y premises
a y Dependancy thereof to do, by, Transact, execute, determine, finish all &
whatsoever y said Constituent my self might or could do, personally present
But if y said all things holding firm & valid all & whatsoever my said
Attorney shall lawfully do & Cause to be done in & about y premises by the
Virtue of these presents, He & his Recovers making null & void all power
Trust & Authority by me formerly granted by Letter of Agency or otherwise
