Jones Notary & Publickly by Royall Authority admitted
and sworn, Dwelling in the City of London, and in the presence of the
Witnesses after named, Personally appeared Katherine Colloton of
London Spinster daughter & Executrix of the last Will & Testament
of S^r Peter Colloton late of the Parish of St James Westminster
in the County of Middlesex Barronett, which appearance hath made & ordained
and in her stead to place putt and constituted, And by those presents dett-
made ordaine and in her stead and place putt and constituted
Robert Ball of Stamford in the County of Lincoln Yeoman now
bound for Carolina in America to be her true & Lawfull Attorney
for, in the name and to the use of her Constituent (in her Capacity
of Executrix aforesaid or otherwise, So as he, Demand, Subj^r,
may recover & receive of and from all and every Person or Persons
whatsoever in Carolina aforesaid, or the places adjacent to Territories
thereunto belonging all and singular such Debts, Dues, duties
Summs & Summes of Money, Wares, Merchandises, Goods, Chattels,
effects and other things whatsoever, which were due & owing unto
the said S^r Peter Colloton or which any way belong unto his Personal
Estate at the time of his death, and which now are & hereafter
shall become due and pay able or any way belonging unto her the
said Constituent in her Capacity of Executrix aforesaid or
otherwise, And upon the receipt of any such Debts, Dues,
Dutys, Summs & Summes of Money, Wares, Merchandises, Goods
Chattels effects or other things aforesaid, and or more acquittances
or discharges, Discharges, for and in the name of
the said Constituent in her Capacity aforesaid or otherwise to make
deeds & deliver or to acknowledge satisfaction upon Record, and
also for and in the name of the said Constituent in her Capacity
aforesaid, or otherwise to Treat and agree and make any Composition
or with any person or persons touching the said Debts
or any part thereof as occasion shall require and become fit to
the said Attorney, and further to apply and disperse out of what
shall be so received of the Personal Estate of the said S^r Peter
Colloton for and towards the payment of all and every such Summs
and Summes of Money Debt & Debts or other things which the
said S^r Peter Colloton justly owed to any Person or Persons at the
time of his death in Carolina aforesaid, or the places adjacent
and Territories thereunto belonging, and moreover for and in the
name of the said Constituent in her Capacity of Executrix aforesaid,
or otherwise to enter into and upon and take possession of all and
every such alleaguages, Lands, Plantations, Tenements & Hereditaments
with the Living and Dead Stock thereunto belonging as the said
S^r Peter Colloton was seized of at the time of his death in Carolina
aforesaid, or the places adjacent to Territories thereunto belonging
and the same for and in the name of the said Constituent in her
Capacity aforesaid or otherwise, So Manure, plant, Manage & improve
in and for the best profit & advantage of her the said Constituent
in her said Capacity or otherwise, And to provide furnish & supply


Supply the same from time to time with all such servants slave
 implements utensils stock and things what so ever as shall be
 needfull and requisite in that behalf, also to place & appoint
 his place and put out such overseer or overseers and other servants
 or servants of or belonging to the messuages lands plantations
 tenements & hereditaments aforesaid for the time being as the said
 Attorney shall from time to time think fitt And all the Merchants
 Grocers & producecons of the same sh^{al}l be to ship off or sell
 giving and hereby Granting unto her said Attorney full power
 and Lawfull Authority in and about the sh^{al}l be for land in the
 name of the said Constituent in her Capacity of Executrix or
 otherwise, in all things to doe Execute & performe what so ever the
 the said Constituent might or could doe personally, Altho the Matter
 require more speciall Authority than herein is comprized, with
 power also to make and substitute one or more Attorneys under him
 with like or limited power and the same at pleasure to Revoke
 or the said Constituent promising to have this to ratify, or cause to
 be had Holog & ratified as good and valid for ever all and whatsoever
 her said Attorney or his substitutes shall lawfully doe or cause to be
 done in and about the sh^{al}l be, In Witness whereof the said
 Constituent hath hereunto set her hand and sealed thus done and
 past in London aforesaid in the presence of the Witnesses hereunto
