In Testimony Francis Turgis Gent. late of this Province deceased
 did intestate by means whereof the Administration of y^e s^d. Francis
 Turgis Estate was committed to Elizabeth Turgis relict of y^e s^d. Francis
 and whereas y^e s^d. Francis Turgis left two Daughters by Name
 Elizabeth and Mary to whom by Right and Law her Shares of the
 Estate of the s^d. Francis Turgis doth belong, w^{ch} Estate in y^e whole
 did of Appraisment amount to y^e Sum of nine hundred forty and
 four Pounds and three p^{ts}. And whereas there is an Intermarriage
 intended between y^e abovebound Joseph Blake and the above
 Elizabeth Turgis relict of y^e s^d. Francis Turgis. Now the Court
 of the above Obligation is such that if y^e abovebound Joseph Blake
 his Exors, Exors Administrat^r or Assignes shall well and
 Lawfully pay unto each of y^e abovenamed Elizabeth & Mary
 Turgis the Sum of Three Hundred and fourteen Pounds
 shill and four pence respectively as they shall Arrive at y^e Age
 Twenty one years or be married it shall be so that y^e s^d. Children
 neede Time shall give and Allow without any Charge to y^e
 s^d. Children or either of them such Maintenance and

Education in this country as shall be thought expedient by y^e above named Elizabeth Fargis Mosher of N. D. Put in and y^e above named John Mosher or either of them, then this Education shall be said or else be annulled for ever & ever.
