

Be it known unto all Men by these Pres^{ts} That Mary Godfrey of the County in the Province of Carolina, Executrix of her last Will and Testament of John Godfrey my late Husband of the County and Province aforesaid have Remitted, Released and for ever Quiet Claimed and by these Pres^{ts} me, my heirs, Executors, Administrators, Assignes do Remitt, Release, & ever Quiet Claim unto Mr. Richard Waller of the Island of Barbadoes all and all manner of Actions, Suits, Debts, Debates, Acc^{ts}, Balance, Acc^{ts}, reckonings, Bills, Bonds, Writings and all other Demands which of or against Richard Waller his Heires, Executors, Administrators or any of them I have had now have or hereafter shall or may be made or to be made by Execution of her last Will & Testament aforesaid. Reason, Force, Colour or Means of any other Act, Matter, Cause or Thing whatsoever it be from the beginning of the World until day of the Date of these Pres^{ts}. In Testimony whereof I have hereunto set my Hand & Seal this fourth day of June 1698. One Third six Shillings Ninety & Eight.

Volna. To all to whom these Pres^{ts} shall come I Abraham Avilah of Charles Towne in the County of Berkeley and Province of Carolina. Greeting

Know ye that I the said Abraham Avilah for divers good causes and Considerations me at this time especially moving and more especially out of Trust and Confidence which I repose in Mr. Simon Valentine M^{ch}, have made, constituted, ordained, and appointed, & in my Head & place put of said Simon Valentine my true and Lawfull attorney for me and in my name and to my use to ask, demand, sue, or recover, & receive of all and all manner of Persons or persons whatsoever in the Province of Carolina or Elsewhere, all such Sum and Sum of money Goods, Wares, Merchandises, Effects, or any other thing & things whatsoever, in and about the said Province to me the said Avilah due and owing or by any manner of wayes belonging or appertaining and to demand, receive, and collect, sue for and bring, seek, at Law, or otherwise, to commence any action or actions for me and my name for such Sum and Sum of money, Goods, Effects, matters, and things, and upon receipt of the same or any part thereof to make and deliver full, sufficient, and discharges for me as my said attorney shall think requisite and necessary and Generally to do, say, execute, performe, fulfill, and accomplish all and every such farther and other acts, things and things, whatsoever, in or about the said Province my said Attorney shall think necessary & expedient to be done as fully & Effectually as I myself might or could do personally. Hereby I attesting & allowing for firm, valid, and Effectual, and as whatsoever my said Attorney shall Lawfully do, or cause to be done in and about the said Province or thereof or thereof as also one Attorney or more under him to make, and at his pleasure again to revoke.
