Norton, their Executors & Assignors, to sue, arrest, Imprison, Impound, & Procees for y^e same
& upon such Suits to proceed to Judgment & Execution & thereupon y^e said Samuel Norton
& such other Person or Persons as shall be in Prison to hold & keep until payment thereof be made
with all Costs & damages incurred & to be sustained by occasion of y^e detaining of y^e same
upon payment thereof y^e said Samuel Norton & such other Person or Persons as shall be in
their Executors & Assignors forth of Prison to discharge & acquittance for y^e same or any part
thereof for us & in our names to make, Seal & deliver & also to perform & execute &
every act & acts, thing & things best for y^e obtaining & discharging of y^e same as shall be
needfull to be done, Giving & by these Presents granting unto our said Attorney our full
absolute Power in y^e Premises, ratifying & holding firm all & whatsoever our said Attorney
shall lawfully do or cause to be done by Virtue of these Presents. *In Witness whereof* we have

whatsoever my said Attorney shall lawfully do or cause to be done in or about the
