Sumes of Money Dues & Dutys what soever which are or shall be
owing and due payable or belonging unto me the said William
Skuller from M^r George Logan, or any other person or persons
what soever within the aforesaid place of Carolina by or upon any
Bill Bond specialty writing, Accompt, Contract, Agreement
or otherwise, how soever by any wayes or means what soever, And
also to Receive all such Goods wares and Merchandises as shall
be by him or any other person or persons what soever and from
whosoever, Consigned unto me the said William Skuller
Giving & Granting by these presents unto my Attorney
full power and Authority in for or about any of the aforesaid
Matters, to sue arrest attach Implead, Imprison and
Condemne, and out of prison to deliver, And also to Compound
agree Release acquit and Discharge, and one or more Attorneys
or Attorneys under him to substitute, and at his pleasure to
Revoke and to do performe and Execute or cause to be done
performed & Executed, all every or any other Act or Acts, thing
or things what soever as well for obtaining a Discharge
of the M^r matters or any of them, or any part of them as shall be
Requisite and needfull, or as by my benef may might or could
be done in person, and all and what soever my said Attorney shall see
doe in for or about the M^r matters. I doo & will Ratify
Confirm and allow by these presents, In Witness where of
I have hereunto sett my hand & Seal this 16th day of June
in the fifth yeare of the Reigne of our Sovereign Lord & Lady
William & Mary by the Grace of God King & Queen of
England Scotland France & Ireland Defenders of the faith
and in the yeare of our Lord God 1693.

Send Greeting, Know ye that I the said Benjamin Rawlings Mariner
for Diverse Good Causes and Considerations mo hereunto moving
have made constituted and ordained and in my stead and place do
put my Loving friend Alexander Parvis Merchant, to be my true and
Lawfull Attorney to take into his possession all or any my goods and Chattels
and the same to sell and Dispose of according to his Discretion to my
best advantage, as also for me and in my Name and to my use to
doke demand sue for paye require recover and Receive of and
from George Legan of the Province of Carolina all and every sum
and sumes of money Goods Merchandizes Debts dues & Demands
which in any Manner of way either in Law or Equity is due to me and in Case
of Deniall or refusal to arrest Imprison and prosecute to Judgment
Sentence Receive final Execution and satisfaction or if need be to refer
to Arbitration all or any difference that shall be depending between
me and him or any other Person or Persons whatsoever releases and
Discharges in my Name to make Seale & deliver. And Generally to do
and doe all things in all Cases as fully and Amply to all Intents
and purposes as if I the Constituant were personally present with
full power to my said Attorney to make one or more Attorney or
Attorneys under him and the same at his pleasure to Receive
and stave to make And I the hereby Covenant Ratify Confirm
and approve and what soever my said Attorney shall Lawfully
do or cause to be done in the premises In Witness whereof I
have adventured to set my hand & Seal this Tenth day of Feb^ry 1695
