of Richard Peterson Sometime of the Province of South Carolina Merchant (by his wife Mary)  
now late Ordained Deputy Constituted and Appointed, and by these Presents Also make  
Ordaine Deputy Constituted and appointing Brother in Law Edmund Carter of the  
Province of North Carolina Esq and Elizabeth Parter (his wife) and one sister  
my true and lawfull Attorneys and Deputies to Demand Act sue for Harry re-  
cove and recover in their own name or in the name of me the Constituent  
and do my own proper use and behalfe of and from all and every person and  
persons in the province of South Carolina or elsewhere in North America all  
and every power and Summe of money Debts Due and Demands that in any  
manner of Way either in Law or Equity are or shall be Due Owing or Belong-  
ing to me the Constituent and unto and upon all or any Lands Houses Posses-  
sions or Hereditaments in anywise belonging unto me to Enter and possess  
them where so ever they be. And the Present Occupiers (if need be) by all Lawfull Wages to Expect  
Expell and amove And the same to Occupy manage and Improve Rent and Lease out and  
own to sell and Disposse of the same for me the Constituent In case of Removal or De-  
nial to sue and prosecute all and every person and persons in all manner of actions  
or suites either at Common Law or in Equity And thereupon to Obtain Judgment  
Sentence or Decree and Execution and final Satisfaction And upon just satisfaction  
or other composition, in my name to make and Execute sufficient Releases and  
other discharges and for me to appear before all Governors Judges and Justices and  
thereto concerned prosecute and Defend all and every Action and Actions Publice and Private  
Matters or Things general personal or Mest and to doe every thing in and about the premises  
that I the Constituent could doe if I were personally present and the said Eleonor or  
herby give full power and authority unto my said Attorneys Edmund and Elizabeth  
one or more Attorney or Attorneys under them to make and have to them at their  
pleasure again to Revake and either to Appoint and Generally to do Execute and performe  
all other necessary and Legal Acts in my behalfe in and about the premises giving  
and hereby granting <sup>Unto my self</sup> Attorneys and their Substitute or Substitutes my full  
power and authority to act and doe in my behalfe as if I were present and did the same per-  
sonally ratifying allowing and confirming all and whatsoever my said Attorneys or their  
Substitute or Substitutes shall Lawfully doe or cause to be done in and about the premises  
In Witness whereof I have hereunto set my hand & seal this September Day of the Eighteen  
in the year of Our Lord one thousand seven hundred and forty eight.
