Know All Men by these Presents that Eleanor White Widow, one of the Daughters
of Richard Peterson sometime of the Province of South Carolina Merchant (by his Wife Mary)
have made Ordained Deputed Constituted and Appointed, and by these Presents doe make
Ordaine Depute Constituted and appoint my Brother in Law Edmund Parter of the
Province of North Carolina Esq and Elizabeth Parter (his wife) and my Sister
my true and lawfull Attorneys and Deputies to Demand Act sue for Levy re-
cover and receive in their own name or in the name of me the Constituent
and do my own proper Use and behoof of and from all and every person and
persons in the province of South Carolina or elsewhere in North America all
and every sum and Summes of money Debts due and Demands that in any
manner of Way either in Law or Equity are or shall be due owing or Belong-
ing to me the Constituent and unto and upon all or any Lands Houses Ten-
ements or Hereditaments in anywise belonging unto me to Enter and pursue
themselve and the Tenant Occupyer (if need be) by all Lawfull Ways to Evict
Expell and remove And the same to Occupy manage and Improve Rent and Lease out And
also to Sell and Dispose of the same for me the Constituent In case of Refusal or De-
nyal to sue and prosecute all and every person and persons in all manner of Actions
or Sutes either at Common Law or in Equity And thereupon to Obtaine Judgment
Sentence or Decree and Execution and full Satisfaction And upon full Satisfaction
or other Composition in my name to make and Execute sufficient Releases and
other discharges and for me to appear before all Courts Judges and Justices and
thereto concerned prosecute and Defend all and every Accord and Actions Sutes and Sutes
Matters or Things real personal or Mixed and to doe every thing in and about the premises
that I the Constituent could doe if I were personally present and the said Eleanor do
hereby give full power and authority unto my said Attorneys Edmund and Elizabeth
one or more Attorney or Attorneys under them to make and knowe them at their
Pleasures againe to Revoke and either to Appoint and Generally to do Execute and performe
all other necessary and Legal Acts in my behalf in and about the premises Giving
and hereby granting ^{unto my said} Attorneys and their Substitute or Substitutes my full
power and authority to act and doe in my behalf as if I were present and did the same per-
sonally ratifying allowing and confirming all and whatsoever my said Attorneys or their
Substitute or Substitutes shall Lawfully doe or Cause to be done in and about the premises
