 made and by these Presents do make Ordain Constitute and
 In my Place and Stead full and Depute my Trusty friend
 M^r Edmund Porter of Charles Town in South Carolina my true
 and lawfull attorney for me and in my Name and for my
 use to ask Demand Due for Leay Return & recover all such
 Sum and Summe of money goods wares dues Accounts Merchandize
 or other Riemands whatsover which are or Shall be due owing
 payable and balanging to me or Detayned from me by any manner
 of waies or means whatsoever within the Government and Province
 of South Carolina aforesd. Giving and Granting unto my Said
 attorney by these Presents my full and whole Power Strength
 and Authority in and about the Premises to have and use all
 Lawfull ways and Means in my name and for my use for
 the recovery thereof and upon receipt of any such debts due
 goods wares Merchandize Sum or Summe of money aforesd. Acquit-
 tances or other sufficient Discharges for me and in my name to
 make Seal and Delivry and Generally all and any other Act and
 Acts thing and things Device and Devices in the Law com-
 mandfull and Necessary to be done in and about the Premises
 for me and in my name to do Execute and Perform as
 fully largely and Amply to All Intents and Purposes as I
 my Self might Could or Would do if I was personally
 present or if the Matter required more special Authority
 than is herein Given and Attorney or Attorneys one or more
 and my S^d Attorney for the Purpose aforesd. to make and Constitute
 and again at Pleasure to make furthermore Giving and Granting
 unto my Said Attorney full Power Power Strength and
 Authority to conclude and make Composition and Agreement on
 my behalf with our James Davis now resident in South
 Carolina concerning a Plantation or Tract of Land formerly
 formerly bought of the S^d Davis on which I now live on
 Core Sound in Defendant Provided the S^d Davis
 is disposed to take South Carolina money in proportion as him
 my My Said Attorney shall see cause to allow Ratifying and
 and allowing for firm and Effectual all and whatsover my
 Said Attorney shall do in and about all and singular
 the Premises aforesd. by Virtue hereof In Witness Whereof
 I have hereunto Set my hand & Seal this Twenty fourth day of
 March in the fifth year of our Sovereign Lord George King
 of Great Britain &c Anno Dom: 1718/9
