 Domini 1716 and in the Third Year of the Reigne of our Sovereign
 Lord George by the Grace of God King of Great Britain France & Ireland
 Defender of the faith &c. before me James Rummidge Notary & Notation
 Publick Residing in London by Royal authority duly admitted, and
 Sworne contain the provisions of the Witnesses hereafter named, Personally
 appeared Andrew Perreval of London Esq^r who declared to have made or caused
 constituted authorized and appointed, & by these presents doth make & cause constitute
 authorize and appoint M^r Joseph Martin of South Carolina Gent. his true
 and lawfull Attorney living and by these presents Intending unto his Said
 Attorney full Power & Lawfull authority for him the Said Constituent in
 his name and to his use its ask demand & recover sue for & by all lawfull
 waies & means Recover & Receive of & from Nathaniel Carr of South
 Carolina Gent. aforesaid Merch^t his heirs Executors and Admin^r & all others
 whom it shall or may concern all & every such Sum & Sums of Money
 Goods Wares Merchandises Effects Estate & Things whatsoever owing belonging
 or in any wise appertaining to him the Said Constituent upon his
 Acct^s of his being formerly employed as the Constituent's Agent touching
 the management of his Plantation in South Carolina aforesaid or otherwise
 and after having for Recovered & Received what Effects and Monies
 or other things are so due & owing to the Said Constituent from the
 Said Nathaniel Carr as afores^d to rent the same to him the s^d appears
 in London in such manner as he shall deem will most conduce
 to his benefit & advantage also to get Turn out and remove the Said
 Nath^l Carr out of the possession of all or any of him the said Constituent's
 House Houses messuages Plantations & Hereditaments Situate
 Situate Houses messuages lying and being in South Carolina
 afores^d also to acct. and View settle and adjust all acct^s with the Said
 Nath^l Carr and the balance thereof to receive and the Said
 Constituent doth hereby further empower his said Attorney to Inquest
 into the management of Edward Arden whom the Said Constituent
 hath placed in South Carolina aforesaid as his agent, pursuant to articles
 made and signed for that purpose and to put him the said Edward
 Arden accordingly into Quiet and peaceable possession thereof also
 to settle & adjust acct^s with the said Edward Arden touching the
 Promises & receive from him the earnings & profits that shall arise
 from time to time from the said Plantation as the s^d appears shall
 order and Direct upon Recoveries & Receipts to give one or more
 acquitances or other sufficient Discharges in due forme of Law
 But in case of Refusal or delay by any person or persons whom it

shall or may congeat do make & render just & true account and
 paym^t delivery & possession & satisfaction in the premises him or them
 therrunto to compell by all Lawfull waies and means, what-
 more also If need be to appeare before all Lords Judges & Justices in any
 Court or Courts there to answer Defend and Reply in all matters &
 Causes Touching or Concerning y^e premises to do say Implead Seize
 Sequester attach Impound and to Condemne and out of prison again
 to Deliver also to Compound Conclude & agree by arbitracⁿ or
 otherwise as the Said Attorney shall thinke fitt & Plein^{ty} in and Concerning
 the Premises to do performe & Execute all & whatsoever shall be Requested &
 necessary as fully amply & Effectually to all Intents constructions &
 purposes as he the S^d Constituent might or could do if personally pre-
 sent & y^e altho y^e S^d Constituent should have more Especial or ample power then is here-
 inbefore particularly Exprest with power to Substitute one or more
 Attorneys in y^e stead of him wth like or limited power and the Same again
 to revoke he y^e S^d Constituent hereby promising to ratify
 Confirm & hold for good & valid all whatsoever this said Attorney or
 his Substitutes shall Lawfully do or cause to be done in or about
 the premises by Virtue of these presents This done & passed in London
 afores^d in the presence of the underwritten witnesses.
