 Reserved Having and hereby Granting unto our said Attorney our full and
 whole strength power and authority in and about the premises and to
 take & use all due mean's course & process in the Law for the obta-
 ining and Recovering the same and of Recovering and Receipts thereof in our
 name to make Seal and Execute due acquittances & Discharges and for
 the premises to appear and the person of us the Constitutants to Represent
 before any Govern. Judges, Justices, officers & ministers of the Law,
 whatsoever in any Court or Courts of Judicature, & thereon our
 behalf to answer defend & Reply unto all actions, causes, matters
 & things whatsoever relating to the premises with full power
 to make & substitute one or more Attorneys under him our said
 Attorney and the same again at pleasure to revoke & finally to
 say, do Act Transact Determine Accomplish & finish all matters & things
 whatsoever relating to the premises as fully amply & Effectually to all
 intents & purposes as well the S^d. Constitutants our selves ought or might
 personally altho the matter should Require more Speciall authority than in
 herein Comprised were the said Constitutants Ratifying allowing and
 Holding firm and Valid all and whatsoever our S^d. Attorney or his Substitutes
 shall Lawfully do or cause to be Done, in and about the premises by Virtue
 of these presents In Witness whereof we have hereunto sett ~~our~~
