 friend Joseph Moody of Charlotte in
 North Carolina Gent. who that and these

Memorandum On the Twenty first day of March
A.D. 1791 I personally came and appeared
before me the Hon. James Moore Esq. J. of the
Court of South Carolina, James Leake
& John Stearns Two of the Justices of the
said Court, who being duly sworn on the holy
Evangelist of Almighty God & each of them
swore that they and each of them was & were
Present and in their minds the above Testa-
ment signed by Patrick and Delaney the above
Witnessing to be & contain his Last Will and
Testament and that at the time of his so doing
he was of sound mind & memory and that
Peter James Moore & William Moore subscribed his
Name and Name in their Presence &
I was before me. Ja. Moore

Carolina I the Name of God Amen I George
Logan of Beaufort County in the Province of South
Carolina being in perfect health of body and of sound
mind and memory thanks to Almighty God first Do
make, Ordain, Publish and Declare, Therefore
to be and contain my last Will and Testament.
I hereby revoking and making Null & Void
all former and other Wills and Testaments by me
heretofore made. First and Principally, I
commend my Soul to Almighty God my
Creator, and by believing that I shall receive
full pardon and remission of all my sins and
be saved by the precious Death & merits of my
Saviour Jesus Christ and I desire that my
body be buried in such decent manner as I shall
manually write my last Will and Testament & be

hereafter named. That I thought and intended
and as touching such Will & Testament as I have
made or may have made to be my last Will
and Testament & meaning is the same. That I have
and intended, as hereafter by this my Will is expressed
that I do give, devise, bequeath, and assign all
that I do possess and in all other parts of the world
I do possess as also the Rent & Profit, accruing from the
Labour of the Slaves on the Plantation on which I
live and where I now reside and the Slaves on the Plantation
commonly called & known by the Name of the above
mentioned George Logan and his management thereof
shall be appropriated and I do appropriate the same
for the paying & Discharging my just Debts and that
no Legacies hereafter by me given, or devised or
any part of my Estate made, shall be paid or
discharged until all my said Debts be first fully paid &
satisfied. Item I do give, devise, bequeath, and assign that
both myself and my Wife Children be and I do hereby
ordain, that there be maintained out of the produce
from the Labour of the Slaves of both the Plantations
before mentioned until the Debts be fully paid and
satisfied. But in case any of them should be unworthy
of having their Legacies hereafter by me given, that
then & in such case their Legacies shall be divided
and I do hereby I do give, devise, bequeath, and assign
out of their said Legacies a proportionable part of the
my said Debts, that shall be then due & owing as
I shall be required by my Executor & Co-Executors
named. Item I do give and bequeath unto my
dear & well beloved Wife of the above named
Slaves (after my just Debts are fully paid and
Discharged as above) by Name, George, Mary
Elizabeth, Rapping, Jack, Jeffrey, Godi, Priddy, Abraham
Murray, Quaco, Fortune, June, Adam, Rosa, India
