 him in hand at or before the Executing & Delivery of these Bonds

 James Holan & Stephen Faceroon the receipt whereof is here
 Acknowledged hath bargained sold & delivered and by these
 Bonds hath bargain sold & Deliver unto the said John Moore
 Samuel Morris, Moses Plummer, James Holan and Stephen
 Faceroon all those his Seven Negro Men named Carolina, Sa-
 for, Seipia, Yee, Mingo & Frank, To have and to hold the
 Bargained Premises unto the said John Moore, Samuel Mor-
 Moses Plummer, James Holan & Stephen Faceroon their
 Admons & Assigns To the only proper use & behoofe of the said
 John Moore, Samuel Morris, Moses Plummer, James Holan &
 Stephen Faceroon their Heirs Adms^s & Assigns for ever.

And the said Ebenezer Ford the said bargained Premises unto the John
 Moore, Samuel Morris, Moses Plummer, James Holan & Stephen Faceroon
 their Heirs Adms^s Assigns against all persons & persons whomsoever
 who shall or may for ever defend by these Bonds Provided always
 that if the said Ebenezer Ford his heirs Heirs or Adms^s or any of
 them shall not & truly pay or cause to be paid unto the said
 John Summers his Heirs Adms^s or Assigns on any of them the full &
 just Summe of eight hundred Pounds Curr^t Money of South Carolina
 on or before the thirteenth day of November next ensuing And also the
 further Summe of Three hundred & Fifty Pounds like Curr^t Money
 on or before the first Day of March now next ensuing And that in
 full Discharge & Satisfaction of the said two recited Obligations
 Then these Presents & every Clause Article & Sentence herein
 contained shall cease Determine & be utterly Void & of noie Effect to
 all intents & purposes any thing herein before contained to the
 contrary thereof in any wise Notwithstanding In Witness whereof the
