the Tutorship and Education of the said Infant  
Children to the said Andrew Rembert according to his desire hereby  
Charging him that he do maintain her in meat drink Washing  
Lauding Cloathing and such good Education as may be fitting  
according to the Circumstance & Interest of the said Infant Child  
during her minority And that the said Andrew Rembert  
do Enquiries and take care and Charge of her Estate both real  
and personal and do other things as a Guardian by law  
may do in a true and faithfull acount thereof and what  
Estate of the said Esther Guerry shall come to his hands to render  
when he shall be thereto required by such Guardian as shall be

first bring remebering and sorry for my sins past most humbly Desiring  
forgiveness for the same Here and Commit my soul unto Almighty  
God my Saviour and Redemeer in Whom and by the merits of Jesus  
Christ I trust and Believe to be saved and to have forgiveness of all  
my sins and that my soul with my body at the general day  
Resurrection shall this appear with Joy and through the merits of  
Christ death and punishment I hope to inherit the Kingdom of Heaven  
prepared for Elect and Chosen and my body to be buried in such  
place where it shall please my Executors hereafter named to appoint  
and now for the settling of my Immortal Estate and such goods  
Chattels as it hath pleased God for above my Desire to bestow upon  
me I do Order give and dispose of the same in manner and form  
following (that is to say) first I will that all my Debts be lawfully  
paid within convenient time after my Death by my Executors  
hereafter named Item for the good love and affection I do bear  
unto my Beloved Wife and for the good will and I bear unto John  
Barnett and John Guerry and for Davis other Executors me thenceunto  
Specially moving I do nominate and appoint my Wife John Barnett  
John Guerry Executors of this my Last Will and Testament Item
