In the name of God Amen I Joseph Thornton of Charles Town
in this province a Carpenter being sick and weak of Body
but perfect Mind and Memory do make and Ordain this to be my
last Will and Testament, as follows (viz) I feel pleasure and my belief
God that Grace and my Body to be decently Buried at the discretion
of my Executors Item my will is that all my Lawfull Debts be first
paid with my Funeral Charges. Item I Give and Bequeath unto
my loving wife Mary Thornton One half of all my personal Estate
for my Debt & Funeral Charges & first paid to her and for her
with the use of my hand during her living my widowed daughter
Mary I Give and Bequeath my House and Land in Charles Town
with the remainder of all my other parts of my personal Estate to her
and her heirs for ever unto my son Samuel Thornton but in case my son
should Die before he comes to the age of Twenty One years then and
such Case I Give and Bequeath my House and Land unto my loving
wife Mary Thornton to her & her heirs for ever Lastly I Ordain and
appoint my well beloved wife Mary Thornton, said wife and
my three sons to be my Executors and Executors of this my last Will
and Testament, revoking all other heretofore made for Writing
whereof I have not mentioned and seal this second day of August
in the Dominion of North Carolina Seven hundred & thirty eight
Joseph Thornton.

Patterson Esq. Lieutenant Governor and Ordinary of the said

Thomas Baker's last will and Testament

In the Name of God Amen the sixth
day of July in the Year of Our Lord God 1793 I Thomas Baker
of Berkeley County in South Carolina a Blacksmith being in
the 6th of Body and in perfect Mind and Memory do hereby
call unto God therefore Calling to mind the mortality of my Body and
knowing that it is appointed for all men Once to Die, Do make
and Ordain this my last Will and Testament, That is to say
Primarily and first of all I Give and recommend it to the
Earth to be buried in a Christian like and decent manner at
the discretion of my Executors nothing Doubting but at the
General Resurrection I shall receive the same by the Mighty
Power of God in due touching such worldly Estate, whosoever it
be, I have pleased God to Bless me in in this life I Give bequeath and
dispose off the same in the following manner and form
I Give my well beloved Son and my wife to my well beloved son
Benjamin in Baker: 150 Acres of Land being the middle part of a
Tract of Land containing 446 Acres now settled in Berkeley
County with all the Buildings and improvements on the same
and one Negro Man named Venture and one Negro woman
named Phillis and my Watch and 2 Gold Rings & Buttons
I Give my well beloved Son Andrew Baker 146 Acres of Land
being the South End of the said Tract of 446 Acres and one Negro Man
named Jack and one Negro Boy named Johnny with one Lot
of 22 in Dorchester Town and all my worldly Goods and Jew-
els I Give my well beloved Son Jacob Baker 150 Acres of Land
being the North End of the said Tract of 446 Acres and one Negro
woman named Oxford and one Negro woman named Lydia
I Give my well beloved Son Thomas Baker 150 Acres of Land
situate in Berkeley County when I was for without the
Buildings and improvements thereon and one Negro boy named
John I Give one 1/3 of a Tract of Land in Berkeley County near the
