have in this life and being in perfect sense and memory blessed
be the Lord therefore Do this twelfth day of November in the
year of Our Lord One thousand seven hundred and thirty six &
the fifth year of the reign of George the Second of Great Britain
France and Ireland King of Great Britain and publish this my
last Will and Testament in manner and form following that to say
I commend my soul into the hands of almighty God
who gave it and my Body to the Earth from whence it came in
hope of a Joyfull Resurrection through the alone merits of my Lord
and Saviour Jesus Christ and as to that Worldly Estate which it
has Pleased God to bestow on me with I dispose thereof as follows to Wit

Whereas the said Thomas Kimberley of Charles Town
Charles Town did by a Deed of Gift or Testament bearing date the
Nineteenth day of November Anno Domini 1731 with the Consent
and approbation of my said Wife Isabel Kimberley testified by her
setting her hand and seal thereto in Consideration of my good
Will and affection to my Daughter in Law Anna Shute Wife of
Joseph Shute and of the Shillings Current money did give grant
Morgan Sell transfer Convey assure and Confirm a tract of Land
Containing six acres English measure be the same more or less
situate in Berkeley County near Charles Town lately bought and
purchased of George Glasgow as by Indentures of Lease and Purchase
bearing Date the fourteenth and fifteenth days of March Anno
Domini 1728 to have and to hold the said six Acres of Land with all
houses Edifices Buildings as shall be thereafter build thereon
and all appurtenances thereon then standing growing or being or
thereunto belonging or in any way appertaining unto the said
Anna Shute Wife of the said Joseph Shute her heirs and assigns for
ever and which deed of Gift or Testament contains sundry
Declarations Covenants agreements and provisions as by the said
deed reference being thereunto had will more fully appear The
said Thomas Kimberley do hereby Confirm and allow of the said
Deed of Testament or Gift and of every thing therein contained
do hereby Devise the said tract to the persons and uses in the said
Deed mentioned according to the intention of the said Deed and
subject to the several Covenants and Declarations therein made
to wit to my said Wife Isabel for Life Remainder to the said Anna
Shute and her heirs for ever Item I give and bequeath to my
Brother John Kimberley One Shilling Sterling Item I do bequeath
and Devise all the Rest and Residue of my Estate real or personal
and all my goods and Chattels to my Beloved Wife Isabel Kimberley
her

and their only proper use and behoof. I do hereby
 and appoint my said Wife Sarah Kimberley sole executrix
 of this my last Will and Testament and hereby do revoke
 all former Wills by me made. In Witness Whereof I have hereunto
 set my hand and Seal the day and year first above Written.

 last Will and Testament, and first I recommend my soul unto
 my Almighty Creator hoping through the intercession of my
 Saviour and Redeemer Jesus Christ to have a blessed immortality
 and as for what worldly goods it hath pleased God to bless me
 with I do give and bequeath in manner and form following,
 Item I give and bequeath unto My loving Wife Sarah Roman
 in lieu of Dowry and to her heirs for ever three Negroes of her
 Own Choice and also one third part of the moveables in the house
 but in case that the Issue of my Wife be male she shall have
 four and if it be female but three Negroes and the plantation
 and One third of the moveables goods and Chattels if any in
 case that the Child shall die before it comes to the age of
 sixteen the or the day of marriage the Childs part to go to my
 Wife Sarah Roman and to have the said plantation during
 her Widowhood and then to go to the next heir the Remain-
 der part to go to my Son. Further I make Sarah Roman during
 his life and after his death to fall to the next heir,
 Item I do give and bequeath unto my loving Wife after my
 just debts and funeral expences are paid the Remainder to be
 Returned to my loving Wife and Lastly I do nominate and
 appoint my friend John Hale and my Brother Thomas Hute
 and my friend Noah Servey to be Executors and Guardians of this
 last Will and Testament, In Witness Whereof I have here-
 unto set my hand and Seal this 11th day of
 March 1736/7.
