

In the name of God Amen This Thirteen day of December 1769 I Anthony Atkinson of the Parish of Prince George in Craven County in the Province of South Carolina Planter being Sick and weak of Body but of Perfect mind & Memory Praise be Almighty God but belling to mind the mortality of the body & knowing that is Appointed for all men once to die do make & Ordain this my Last Will and Testament in manner & form following that is to say Principally and first all I Recommend my soul to God that gave it and my Body I Commit to the Earth to be Buried at the Discretion of my Exors: hereafter named and as to my Worldly Goods & Estate I Give Devise & Dispose of the same in manner and form following

Impairnis I Give and Bequeath to my Son George Atkinson ~~to his heirs forever~~ one Town Lot in Georgetown known in the Plan or modell of the s<sup>d</sup> George Town by the number (129) and all my household Goods to my s<sup>d</sup> son George Atkinson & to his heirs forever Item I Give and Devise to my Grand Son Anthony Mitchell and to his heirs forever one Town Lot in George Town known in the Plan or modell of the s<sup>d</sup> George Town by the number One hundred & thirty Item I Give and Devise unto my son George Atkinson and to my son in Law Thomas Mitchell both whom I hereby Appoint Exors: of this my Last will & Testament all & singular my real and Personal Estate / Except as above bequeathed / consisting of Lands whereever Situate that I am Possessed of at the time of my Decease also all my negro Slaves neat Cattle horses & Yares &c<sup>a</sup> or whatsoever Belongeth or in any wise Appertaineth to me at the time of my Decease as afores<sup>d</sup> and I do hereby Give full and absolute Power & Authority to my s<sup>d</sup> son George Atkinson and to my s<sup>d</sup> Son in Law Thomas Mitchell or the Survivor of them my s<sup>d</sup> Exors: to sell & Dispose of all or any part or Part of my Lands and to sell and Dispose of all or any part of my Personal Estate and the moneys arising thereby to be Applied towards the Payment of my Debts or otherwise if my s<sup>d</sup> Exors: or Exors: shall think fit to continue the Slaves or any Part of them on the Plantation they have hereby full Power & Authority so to do: Provided that my Creditors are Satisfied and whatsoever shall remain of all my Real & Personal Estate after the Payment of my Debts I Give and Bequeath to my s<sup>d</sup> son George Atkinson and to my s<sup>d</sup> Grandson Anthony Mitchell to be Equally Divided between them Share & Share alike to them and to their heirs or Assigns forever And Lastly Do nominate & Appoint my said son George Atkinson and my son in Law Thomas Mitchell both of Craven County in the Province of South Carolina Exors: of this my Last will & Testament and I do hereby utterly Disallow Revoke & Disannul all and every other former Testament Wills Legacies & Bequests & Exors: by me in any wise named Willed or Bequeathed Ratifying & Confirming This and no other to be my

In the name of God Amen I Andrew Warnock of Berkeley County in the Province of South Carolina Planter being Sick in body but of Sound Disposing mind and Memory Blessed be God for the same do make and ordain this my Last will & Testament in manner & form following First & Principally I Commend my soul into the hand of Almighty God hoping through the Satisfaction & merits of my only saviour & Dear Redeemer Jesus Christ to have full & free Pardon of all my sins and to Inheret Eternal Life my body I Commit to the Earth to be Decently Buried at the Discretion of my Exors: and Exors: hereafter named and Teaching such Temporal Estate as it hath Pleased God of his Infinite Mercy to bless me with I Give & Dispose thereof as follows Impairnis I Will that all my just Debts and funeral Charges & Expenses be first Paid Item I Give and Bequeath unto my Loving wife Pharamazon five Slaves by name Dinah Wacomaw, Peter, Luina Peter, Harry, & Cuffie and one Ring horse named Pacolet with a Side Saddle and also to have the Sixth part of what Income may be made on my Plantation during my Widow & know Longer & my meaning is that what Slaves I have herein Given her shall be Included with the rest of my Slaves to Work for the Maintaining of my Children During her Widow hood and she to draw but the Sixth Part of the whole Income yearly during her Widow hood But I do hereby Declare that the Several Legacies Gifts & Devises by me herein bequeath unto my s<sup>d</sup> wife are so Given unto her and are meant & Intended to be in full Satisfaction and Barre of all such Dower and title of Dowers and Interest & Customary Part Share or thirds of my real or Personal Estate which she can or may claim by any Right or title or Custom whatsoever Item if any of my Children to whom is hereafter herein Given & Devised should die before they come to age to Inheret & have no Issue then I order that their Share or Part Given & Bequeath real or Personall to be Equally Divided and Shared among the rest of my surviving Children

Item I Give and Bequeath unto my Daughter Pharamazon one negro Girl named ~~Phibey~~ Phibey with her hereafter Increase to her and her heirs forever  
Item Whereas my wife Pharamazon is now Pregnant with Child if in Case it should be a Daughter

When Born then I Give and Bequeath her one negro Girl named Joan to her & her heirs forever and in Case it should be a Son when born then he shall have an Equal part or Share of my real Estate with the other of my sons Viz: Andrew Abraham, John & Sam<sup>r</sup>. Warnock's Item I Give and Bequeath unto my Sister in Law Mary Warnock one riding horse named Bowler and the sum of twenty five Pounds Current Money to be Paid her Six months after my Decease Item my will is that the Share or Part which my wife is to have or Receive out of the Lands which her Late father Abraham Warnock that the same shall be Divided & Shared Equally amongst all my Children or the Survivors of them to them & to their heirs forever Item I Give Devise and bequeath unto my sons to wit Andrew Abraham John & Sam<sup>r</sup>. Warnock's and to the son that may be born of which my wife is now Pregnant off all that Plantation or tract of Land whereon I now live with all thereunto Belonging to have and to hold the s<sup>d</sup>. Plantation or tract of Land to my above named sons or if Survivors of them to be Equally Shared or Divided among them or the Survivors of them when they shall Attain the age of Eighteen years to them and to their heirs forever Item I Give Devise and Bequeath all the rest & Residue of my Personall Estate that has not already Given or bequeathed unto my Children to wit my son's Andrew Abraham John & Sam<sup>r</sup>. and to my Daughters Phamaron Rachel and the one that may be born to be <sup>Equally</sup> Shared or Divided amongst them or the Survivors of them to them and theirs forever Item and I do hereby nominate and Appoint my Loving wife Phamaron Exec<sup>r</sup>: as long as she shall continue my widow & no longer and my two brothers Jos: & Sam<sup>r</sup>. Warnock's and my Good Friends William Allston the son of the late William Allston Sen<sup>r</sup> and James Fisher with my son Andrew Warnock when he shall Attain the age of Sixteen years to be Exec<sup>r</sup>: of this my Last will & Testament hereby revoking making null and void all former & other Will & Wills by me heretofore made & this to be and stand as & for my Last Will & Testament In Witness whereof I the s<sup>d</sup>. Andrew Warnock have to this my Last will & Testament Set my hand & Seal this twenty fourth day of December in the year of our Lord One thousand Seven hundred and forty & nine
