In the Name of God Amen I Daniel Dwight Rector of the Parish of St. Johns in Berkley County in the Province of South Carolina being of sound and perfect mind Memory and understanding and considering that it is appointed for all men once to dye do make and ordain this to be my last Will and Testament in manner and form following Imprimis I recommend my Soul into the hands of Almighty God thro' the Merits and Mediation of his ever blessed Son Jesus Christ and my Body to a decent burial in the corner of the Church Yard at Childsburgy where my dear Wife and two Children lie Interred with this Inscription (if any) upon a Stone or Monument affixed to the head of my Grave Here lyeth the Body of Daniel Dwight late Rector of this Parish who departed this Life in peace such a day such a year I die in the safe Communion of the Church of England In which I have lived constantly endeavouring to recommend its constitution to all who were either disaffected or Strangers to it And as Touching my Worldly Estate I give and dispose thereof in form and manner following first I will and ordain that all my just Debts be fully paid and Satisfied Item I Give Devise and Bequeath all my Lands Tenements and Hereditaments whatsoever and wheresoever together with all the Appurtenances thereto belonging to and amongst all my Children their Heirs and Aftigues forever to be equally Divided Between them regard being had to their Quality and Value only And I will and ordain that my Exors hereinafter named and the Survivors and Survivor of them or so many of them as shall take on them the probate of this my last Will & Testament shall have power to Divide and Apportion my said Lands &c. to my said Children respectively as they shall respectively attain the age of twenty & one Year and my will is that in case either one or more of my said Children

should die before he ^{or they} respectively attain the said Age of twenty one Year and leave no Lawfull Issue behind them that then his or their part & share in my said Lands Tenements and Hereditaments shall remain & go to my other surviving Children equally their Heirs and Aftigues forever Item I Give Devise and Bequeath to my said Children forever all my personal Estate Goods & Chattells forever to be equally Divided between them as they shall respectively attain the age of twenty one years and I will and Ordain that my Exors hereinafter named and the Survivors and Survivor of them be Guardian to my said Children till they shall respectively attain the age of twenty one Years

Item I do hereby nominate ordain will and appoint Timothy Dwight of New England Esq. Coll^r Francis Lejeune Thomas Broughton Esq. Eldest Son of Nathaniel Broughton Esq. Mr William Alstone of Wacamaw and my Eldest Son Thomas Broughton Dwight Exors of this my last Will and Testament and I do hereby revoke disannull and make void all former and other Wills by me at any time heretofore made and do publish and declare these presents to be and contain my only last Will and Testament In Witness whereof I have hereunto set my hand and Seal this twenty Sixth day of July and In the Year of ^{our} Lord one thousand seven hundred and forty four and thus having endeavoured to set my House in order I humbly beseech the great God who has so graciously conducted me through the changes & chances of this World never to leave me nor forsake me but of his great goodness and in his own time to Grant me a safe and easy passage to everlasting felicity thro' Jesus Christ Amen

This Will was proved before his Excellency the Gov^r the 6 May 1748 by the Oath of John Hentie and Thomas Broughton and Francis Lejeune two of the Exors therein named were qualified at the same time

In the Name of God Amen the twenty fourth day of March one thousand seven hundred and forty seven I John Jackson Sen^r of Colleton County in the Province of South Carolina Planter Being of mind Memory and understanding well & firm do dispose of my Estate both real and Personal in form and manner following Imprimis my will is that ^{all} my just and Lawfull Debts be paid for the discharge whereof I do hereby give full power and Authority to my Exors hereinafter mentioned to Sell and dispose in the first place of my Stock of Horses and Cattle at South Charleston and if that should not be sufficient any of my Lands & Town Lots not yet disposed off in Jacksonborough which my said Exors shall think fit and the remainder of

my lands to be equally divided between my loving Son John Jackson and my loving Daughter Jane Butler to them and their Heirs forever. Item I give and Bequeath unto my well beloved Wife Jane Jackson any one negro Woman in the plantation which she shall choose as also one riding horse and Saddle one Bed and furniture half doz. Chairs one large Mahogany Table one dressing Glass one Chest Drawers all the China, and Silver Tea Spoons to her and her heirs forever. Item I do give and Bequeath unto my well beloved Daughter Jean Butler one negro Girl named Hager to her and her Heirs forever. Item I do give and Bequeath unto my well beloved Daughter Esther Jackson one Bed & furniture as also one hundred and fifty pounds Lawfull money to be paid her yearly and every year during her life out of my Estate (that is to say) out of the three Divisions — hereafter mentioned, for her maintenance and if any of the Sum is not expended at the end or Term of any year it shall be put to Interest for her life only. Item I do give and Bequeath unto my beloved Son Charles Butler my new Gun to him & his Heirs forever. Item I do give and Bequeath all the remainder part of my Estate after paying my just and Lawfull Debts & Legacies above mentioned to be equally divided into three parts between my beloved Wife Jean Jackson my beloved Son John Jackson and my beloved Daughter Jean Butler to them and their Heirs forever. And Lastly I do make constitute ordain and appoint my well beloved Wife Jean Jackson Executive my beloved Son Charles Butler and my loving Brother George Jackson Executors of this my last Will & Testament. In the Name of God Amen this twenty fifth day of April one thousand seven hundred and forty eight I William Cornin of Edisto Island in the Province of South Carolina being Sick in Body but of Sound memory and perfect judgment praise be given to God for the same and knowing the uncertainty of human life on Earth and being desirous to settle my affairs and things in order do make this my last Will & Testament in manner and form following; that is to say first and principally I commend my Soul to Almighty God my Creator assured by believing I shall receive full pardon and free remission of my Sins and to be saved by the precious Death and Merits of my blessed Saviour and Redeemer Christ Jesus and my Body to the Earth from whence it was taken to be buried in such Decent and Christian manner as my Executors hereafter named

shall be meet and proper and Touching such Estate and worldly Interest as I have in every hath lent me, my Will and meaning is the same shall be employed and bestowed as hereafter by this my Will is expressed. And first I revoke revocance frustrate & make void all Wills by me formerly made and Declare and appoint this only to be my last Will and Testament. Inprimis after paying my Lawfull & just Debts I will and Bequeath to my Cousin John M^cKulloch & his Wife Betty — M^cKulloch the Grop now up on the Ground all my Stock of Hogs the two Cows all my Household Goods Excepting my Body Cloaths which I leave unto Andrew and John M^cKarlies as also two Guns and Muster Accoutrements I give & Bequeath unto the Presbyterian Church upon Edisto Island for the support of a Minister whose principals is Agreeable to the Established Fundamentals of the Church of Scotland a negro Man named Prophet also a negro Girl named Hanna and all my Horn'd Cattle I will and Bequeath unto David Alexander of Edisto Island a negro Wench named Chloey for his and his Heirs use it is my pleasure that John M^cKulloch Sen^r give unto his Daughter Mary M^cKulloch thirty pounds Currency I give John M^cKulloch Sen^r the use of the following negroes during the natural life of his Wife Betty M^cKulloch Vir^g Caesar, a wench Rose, Dollie, Marya, & Rose and upon the Decease of his said Wife then these negroes is to be sold at Vendue and the money to be equally divided betwixt the above named Hance Andrew and John M^cKulloch Jun^r and Andrew and John M^cKarlies and the said M^cKarlies part to be put on Interest by the s^d Hance Andrew and John M^cKulloch till the said M^cKarlies is of age when they are to have their part. Lastly it is my Will and pleasure that the negro man I have given to the use of the meeting House & the Wench I have left David Alexander remain upon this plantation till the Grop now upon the ground is made and hoking is over then to be applyed for the uses above mentioned. I appoint constitute and Ordain William Edings Sen^r James Butthbert and William Jenkins of Edisto Island as Executors to this my last Will and Testament as
