In the name of God Amen I Nathaniel Snow of Bulky County in the province of South Carolina being in perfect health mind & memory thanks be given to Almighty God for the same do make and declare these presents to be & contain my last Will and Testament first, and principally Recommending my Immortal Soul into the hands of Almighty God my heavenly father trusting in the merits of my Blessed Saviour for pardon & remission of all my sins and a happy admission into the regions of Bliss and Immortality and as touching the disposition of such worldly Estate with which it hath pleased God to bless me I do devise and Bequeath the same in manner following that is to say I do give and Bequeath unto my Daughter Mary Snow young and old good & bad Equally divided by Sort of my Ex^{ts} hereafter named and all the horse and cattle kind that are known to be his and his due to him and his Ex^{ts} adm^r & assigns forever I will and do give and Bequeath unto my Daughter Mary Snow young and old good & bad Equally divided by Sort of my Ex^{ts} and all the horse kind that are known to be hers to her and her heirs also I give to my Daughter Mary Snow the sum of five hundred pounds currency I will and do give & Bequeath unto my son George Snow five hundred acres of land of my tract of two thousand acres at Winyaw & six Negroes young & old good and bad Equally divided by Sort of my Ex^{ts} hereafter named and all the horse and cattle kind that are known to be his the negroes to be divided

by Sort as before mentioned to him & his Ex^{ts} adm^r & assigns forever I will and do give and Bequeath unto my son James Snow five hundred acres of land of mine my old tract at Winyaw and six negroes divided by Sort as before mentioned and all the cattle and horses that are known to be his to him and his Ex^{ts} adm^r & assigns forever I will and do give unto my son John Snow five hundred acres of land off from my old tract at Winyaw and six negroes divided justly by Sort as before mentioned and all the cattle & horses that are known to be his to him and to his Ex^{ts} adm^r & assigns forever I will and do give and Bequeath unto my son William Snow four hundred acres of land at Winyaw which is a plat and Grant for above and six negroes divided by Sort as before mentioned and all the horse & cattle that are known to be his to him and his Ex^{ts} adm^r & assigns forever I will that I do give & Bequeath unto my son William Snow two hundred pounds currency when he arrives at the age of twenty & one years I will and do give and Bequeath unto my Daughter Ann Snow the plantation or tract of land I now lie on containing one thousand five hundred & fifty eight acres of land on lower creek next to her father's former when she arrives to the age of nineteen years I will that the surplus and Remainder of my Real & personal Estate be divided amongst my afore named children and lastly I nominate & appoint Mr Richard Singleton and my son George Snow and my son James Snow to be my Ex^{rs} of this my last will & Testament In witness I the said Nathaniel Snow to this my last will & Testament have set my hand & seal
