Single, Being Sick in Body, but of Sound Disposing Mind & Memory (Blessed be God for the Same) do make & Ordain this my Last Will & Testament, in Manner & Form following, first and principally, I commend my Soul into the hands of Almighty God Hoping through the Satisfaction & Merits of my Only Saviour & Dear Redeemer Jesus Christ to have full & free Pardon of all my Sins & to inherit Eternal Life. My Body I Commit to the Earth to be decently Buried at the Discretion of my Executors & Executors hereafter named. And Touching such Temporal Estate as it hath pleased God of his Infinite Mercy to Bless me with I give & Dispose thereof as followeth I Intend & will that a ^{part} of my Last debts & funeral Charges & Expenses be first Paid & discharged I give & bequeath unto my Loving Wife Sarah Allston, The Sum of Three hundred pounds Current Money of South Carolina to be paid her After all my Lawfull debts are discharged And which shall be in full Satisfaction & Bars of all such Lower Rank Title of Dowers, & Interest & Customary part I have or think of my Real Estate which she can or may claim by any Right or Title or Custom whatsoever. Item I Give & bequeath unto my said Wife Sarah the fifth part of all my Personal Estate after my Just debts be fully discharge, (as also her Maintenance on my plantation & the Liberty of my House during my Widow) to her & her heirs for Ever

Item I Give & Bequeath unto my three Children, named Charles, Peter & Elizabett (and as my said wife Sarah is now Pregnant with Child) to the Child which may be Born, the Other fourth part of my Real & Personal Estate of what kind soever to be Equally Shared & divided amongst them Share & Share alike as they shall attain the Age of Majority & my Daughter or Daughters when they shall be married to them & their heirs for Ever, And if Any of my above named Children (& the one that may be born) to whom is herein Given & bequeathed should dye before they come to Age to Inherit & have no Issue then I Order that their Share or part Given & Bequeathed them Real or Personal to be Equally divided & Shared amongst the Rest of my Surviving Children Item I Give & Devise my Land whereon I now live with all thereunto belong in St. Thomas Parish containing four hundred & twenty Acres, to my Executors hereafter Appointed or the Survivor of them (viz) my Brother in Law Joseph Warnock, my friend Anthony Bonnneau, & their heirs for Ever, Upon Trust that they shall Dispose of the Same in fee Simple to such persons as shall Offer the highest for the Same, (when they shall think fit, or at farther when my eldest Son Charles, shall be of Age) And the moneys arising from the Sale thereof together with my Personal Estate, After my debts are paid to be Shared in Even & Equal Portion amongst my above Children, Charles, Peter, Elizabett - (& the one to be Born) to them & their heirs for Ever. Item I do terminate & Appoint my said Loving Wife Sarah Executrix of this my Last Will & Testament so long as she shall continue my Widow & no longer, And my Brother in Law Joseph Warnock, my friend Anthony Bonnneau Executors of of this my Last Will & Testament hereby Revoaking & making Null & Void all former & Other Will & Wills by me heretofore made & this to be & stand as if for my Last will & Testament In Witnes whereof I the said Peter Allston, have to this my Last will & Testament set my hand & Seal this ~~first~~ Day of April In the year of Our Lord one Thousand Seven Hundred, forty & eight

 Personal Estate that I possess, shall be immediately be sold & all my Lawful
 Debts discharged & what moneys are over & above the discharging of my
 Debts, it is further my Will & Pleasure that the same shall be put out to Interest
 for the Support & maintenance of my ever loving Daughter Mary Weatherley
 in Victualing, cloathing Education & in such other necessaries as she will
 stand in need of so far forth as her Interest will allow & when she arrive
 to the Age of Twenty one or Day of Marriage my Will & Pleasure is that
 the principal Sum of money that I have desired to be put to Interest -
 shall be paid to her, her Husband giving Security for the same & if she should
 die leaving no Lawfull Issue, I then give & bequeath the same Sum of
 Money to be Equally divided between my Loving Brothers Isaac Weatherley George
